At the OSHA meeting a while ago, Selectman offered Administrative help for this project. They are going to pursue this and try to get together with the person helping, to get started with this. The Chief will ask if there are any members interested in helping.

The Deputy presented an offer to have the Stations plowed this winter. The Commission accepted T. Law's offer, which remains at the same cost of previous years.

The Christmas party will be sometime this month, but the date has not been set yet. Boards of Selectmen and Finance approved money for turn out gear.

The Commission will start looking at the 2014-2015 budget early in the new year.

There was no Engineer's report.

Fire Marshal submitted Activity Report, bills. Kirtland Commons is all set and gave an Inservice to the residents.

There was no Chairman's report.

Under Other Business, Spitzschuh questioned a fence at the Olsen property, and if there would be emergency access if needed.

Bowden had been asked to look into a boat trailer for the fire boat. He brought some information in, and made a recommendation.

He also suggested the presence of fire apparatus at events where there are a lot of young people, to spark interest and possibly get a few new members

There was a discussion on Mount Saint John. The Chief would like to have the contact person's name, and possibly in the future approach him with the possibility of looking into water sources on the property sometime next year
