He also found out that insurance on "Beulluah" was set at \$7,000.00. It has now been raised to \$ 40,000.00

There may also be grant money available to purchase more gear.

Under Old Business, Budney asked to have the Commissions's vote for officer's be delayed until the Department elects their officials, and vote on all of them at the same time.

There is a final inspection of the new truck toward at the end of this month. There has been a lot of communication about this truck recently. A February delivery is expected. . The new buyer of the old truck has been very patience, and had rented a place to store the old truck he purchased, back in September. 2013. The Chief will be looking for funds from to compensate the buyer for his efforts and patience.
