The trip to PA for the final inspection of the new truck went very well. It was discovered that the builder of the new truck has claimed bankruptsy. The Town has been alerted to this and feel parts to service the truck can still be found in the future.

There was no Chairman's report.


There was no Other Business.


- 01/01/2014 Fire Department response to 198 Main Street for a lift assist. Units assisted the ambulance crew & secured.
