Water holes came in over budget, and a new permit was taken out and will be used for this year.

There was no Chief's report. However he said that a member did some brush cutting around Winthrop Station, and the Town will send someone out to chip what has been cut.

Deputy reported he worked on some waterholes and obtained permission from a new homeowner to do work on his property. This will take any liability away from the home owner.

There was no Engineer's report. Chief said two tires were put on the Rescue Truck.

Fire Marshal submitted Activity Report, bills.

The process for Tent Events was discussed. The Fire Marshal will speak to the Selectman regarding this process.

Under Other Business, Bowden told the Commission that the boat trailer was on order, and should be received in about a week.

Lee stated that there have been three meetings with the Building Committee thusfar, and it was going well. There has been a lot of good input from the members.

He also asked that if anyone knew of any properties coming available, to let the Building Committee know, as they are still looking for a place to possibly build a new Station.
