The Oct. 6, 2014 meeting of the Deep River Fire Commission began at 7:00 P.M. with Spitzschuh, Lanouette, Lee, and Budney. Fire Marshal Nolin, T. Ballantyne, and J. Kollmer were also present. Bowden was excused.

The minutes of Sept. 8, 2014 were accepted with a correction, The Fire Marshal's report should say Fire Marshal gave an elevator key to the Chief to give to Woodcock. Moved by Lee. Unan.

The Financial Statements were reviewed. A bill for First Line should have been posted under Vehicle Maintenance.

All bills were normal.

Chief reports 13 calls.

The fireworks went well, although he had a hard time finding coverage for the hours before and hour after the show.

Hose and ladder testing was done.

New 5" pipe was purchased to replace old 4" pipes.

A new email was created for the Fire Marshal, but has not been distributed to all areas of the Town Hall that may need to contact him.

The Town is looking at space at the old Visiting Nurses's location to be used as an office and filing area for the Fire Marshal. He should have his own, separate entrance.

Lanouette will follow up with Smith, making sure the location and space is adequate.

The ongoing issue with a resident where a waterhole was placed, will be taken care of by Smith.

For a few months, the Chief has been working at getting a new vehicle to replace the Crown Victoria. A few options may be available for a new Chief's car.

Fire Marshal submitted Activity Report, bills.

There was no Other Business.

Under Old Business, Bowden left word that the boat trailer should be in by the end of the week.


- 09/04/2014 5FM conducted a tent inspection at 245 Main Street, the Deep River Historical Society.
