March 8, 2016

The March 7, 2016 meeting of the Deep River Fire Commission began at 7:03 P.M. with Spitzschuh, Lee, Bowden, and Budney. Lanouette was absent. Acting Fire Marshal Kerop was also in attendance.

The minutes of the February 1, 2016 were reviewed and accepted as written. Moved by Lee, 2<sup>nd</sup> Bowden. Unan.

The Financial Statements were reviewed. Physicals will run over budget. Vehicle Maintenance will also be over budget. There are some bills to be submitted now, and end of year maintenance on all the trucks are due. The cost of the maintenance is \$1,000.00 each. It may be possible to wait until later, and pay this from bothh 2015 and 2016 budgets.

Chief reported 38 calls last month. 19 of them were during a snow storm on February 5<sup>th</sup>. There was one personal injury claim during a call. A member slid on the ice while exiting the truck during a call. That call also produced cosmetic only damage to a responding apparatus. All reports were filled out and filed.

Grant money for a Mobile Command Center, will be used to map out incidents.

The Deputy asked if Dale Winschel, of the Emergency Operation Center, could use Fire Headquarters during incidents. No one on the Commission was opposed to the proposal. He also thinks the purchase of a compressor is inline, after a charge of \$135.00 was incurred after the need to inflate tires on some of the vehicles. There was a discussion on where to send the Engineers to price out a compressor. This will be revisited at the next meeting.

He also said while the Department answered a call in Westbrook, he stayed back at Winthrop Station, and was overwhelmed exhaust smoke. At this time he requests, something is put into the budget to provide an exhaust system for that building. There was also a lengthy discussion on the progress of the Building Committee. It was also mentioned that a tax bill for the adjoining building was received. This building should be exempt from taxes at this time.

Fire Marshal submitted January and February Activity Reports. They were reviewed. He said he has done some work on the INFERS system, and has filed information. This should be completely updated in a few days.

There was no Engineer's report.

There was no Chairman's report.

Under Other Business, Budney asked if there was any information concerning the ongoing Worker's Comp discussion. Bowden did not have any infinitive answers at this point.

Bowden inquired why the whistles still sound off. It was explained the whistle go off until a certain time at night, partly to alert Townspeople of emergency activity, and later in the night, if it is a second alarm.

The budget was reviewed. Requests for funding was evaluated. Lee will work up the numbers before the budget is turned in. Spitzschuh will call to find out when the Fire Commission budget will be discussed, so the Commission can attend to justify the money they are requesting.

The 5yr Capital Expenditures was also discussed.

The commission reviewed applications for the Fire Marshal position. There was a discussion about the applicants. Bowden will pursue legal advice on matters concerning the applications.

There was no Old Business.

Meeting adjourned at 9:28. Moved by Budney, 2<sup>nd</sup> Spitzschuh. Unan.
