The March 6, 2017 meeting of the Deep River Fire Commission began at 7:04 P.M. with Lee, Budney, and Bowden, David, and Dube. Fire Marshal Kerop was also present.

The minutes of February 13, 2017 were reviewed. Accepted as written. Moved by Lee, 2<sup>nd</sup> by David. Unan.

Financial Statements were reviewed. \$1,500.00 was credited to Vehicle Maintenance. All other bills are normal.

Chief reported the Community Breakfast was a success. About 120 meals were served. The Truck Committee is doing well.

There was no Deputy's report.

Under Engineer's report, Chief reports 2" hose was purchased to replace 2 ½" hose on 554. Performance will be the same as with the 2 ½" hose.

Fire Marshal submitted Activity Report. This was reviewed and briefly discussed. He is still working with the Riverwind Inn and Kirtland Commons. The fourth quarter INFERS report was submitted to the State.

There was no Chairman's report.

Under Old Business, David is looking into how the Incentive Program for retirees, or vested personnel is conducted. After speaking with the Town's Attorney and Selectman, it was recommended that the language may need to be changed. He is still trying to get the documentation on who is collecting these benefits. There was also a discussion on who should be named as the representative from the Fire Commission, to be on the Standing Committee overseeing this plan.

The compressor was discussed. The Chief said they were working with Shipman's to fix the system, the cylanoid will not close. The Commission agreed to spend more money to fix the problem, because the cost to fix it, was a lot less than replacing it. He will follow up with Shipman's.

What to do with the Air Bottles was also discussed, as well as the masks.

An exhaust system for both buildings was discussed. The current system in mind, is easy to adjust and/or move. The cost of this system is as follows: Headquarters \$32,300.00, Winthop Station, \$25,500.00.

Chief will adjust the 5 year capital to include: year 20-21 Diesel Exhaust System, and 21-22, Compressor.

Bowden had some concerns about work needed on the boat. He has made some calls. And will wait for answers before proceeding.

There was no Other Business.

Meeting adjourned at 8:05. Moved by Bowden, 2<sup>nd</sup> David. Unan.
