TOWN OF DEEP RIVER Board of Finance Regular Meeting July 28, 2009

The Board of Finance convened its Regular Meeting at the Deep River Town Hall on July 28, 2009. Meeting called to order by J. Bauer at 7:34 PM. Members present: R. Balducci, N. Coutant, L.Guerette, D. Routh. Also present R. Smith, R. Daniels, R. Marth, T. Lindner, Ruth Levy Superintendent, and Board of Ed members Linda Hall, Duane Gates and Lauri Wichtowski.

Approval of Minutes: on MOTION made by D. Routh, seconded by R. Balducci, to approve Regular Meeting Minutes of June 23, 2009. Discussion of **New Business:** amended to note it was a discussion of a meeting to be held with McGladrey & Pullin, auditors. Motion CARRIED to approve amended minutes unanimously.

Treasurer's report: T. Lindner presented Town Deposits Report for review.

Audience of Citizens: Ruth Levy, Superintendent of Region 4, and Linda Hall Region 4 Board of Ed, presented the school regionalization proposal draft, requested additional input from Selectmen and Board of Finance. Discussion of need to make public information gathered in the past and who is involved in current process. Additional comments, financial ramifications, implementation timeline, maintenance discussed.

Recommendation of Selectmen: memo of July 28, 2009 from R. Smith with supporting documentation concerning OPM arrest warrants, Trooper Cope report, memo to accounts manager, monthly fire marshal report, electricity savings analysis and agreement with Consolation, appropriation request of \$6,000 from Fire Commission, Insurance Renewal, and memo of budget transfers and appropriations.

Actions on Recommendations of Selectmen: On MOTION made by N. Coutant, seconded by D.Routh, to approve transfers as noted. Discussion noted transfer required from Capital Non-Recurring of \$60,000 which was included in budget preparation. Appropriation will be made from the UGF. Noted difference after adjustments of expenses vs. revenues of \$29,121.82 for these requests. Anticipate UGF balance after expenditures would be less than projected at budget time, but some revenues have not been received. Noted previous appropriation of \$311,000 for town garage, oil tank, Plattwood Park. Auditors to be starting in August. Motion CARRIED unanimously.

On MOTION made by N. Coutant, seconded by L. Guerette, to approve requests as noted. Discussion concerning additional revenues, UGF percentage, all expenditures addressed in a timely manner, expenditures over \$20,000 will go to town meeting for approval. Motion CARRIED unanimously.

Correspondence: tax collection report, memo from Fire Commission referred to Selectmen.

Monthly Budget Report Review: monthly report received for review.

Old Business: Update from R. Daniels on VNA, noted received revenue of \$352,489, billed services of \$25,748 not yet received, comments from billing consultant company indicate that 15-18 months worth of billing had not been sent out, approximately \$52,000 of unrecoverable revenue due to time lapse, cost to town of \$20,000 for hiring billing consulting company services. Discussion of alternate billing options. Discussion to get a legal opinion for options to the town. Question of why supervisor was not better monitoring billing clerk and other concerns. Noted Selectmen are forming committee to review VNA options, still looking for committee members.

New Business: none
