# BOARD OF SELECTMEN

### DEEP RIVER TOWN HALL

Regular Meeting - November 8, 2011

This regular meeting was called to order at 6:35 pm by Dick Smith.

A motion was made by Thompson, 2<sup>nd</sup> by Smith, to accept the minutes of both meetings.

#### Proposed Contract Between the Town and the Deep River Municipal Employees Organization

Thompson moved, Smith 2<sup>nd</sup>, to approve the contract as agreed to with union representatives. The agreement is retroactive to July 1, 2011 and will remain in effect through June 30, 2014.

#### **Deep River Town Hall Restoration Association**

DRTHRA President Joe Miezejeski, Treasurer Fran Strukus and spokeswoman Board member Sally Carlson-Crowell updated the Board of Selectmen on the Association's decision to dissolve the Corporation in favor of a Town-appointed group to oversee the auditorium's future. Thompson submitted a detailed plan for a transition between the DRTHRA, Inc., and the proposed new committee, which would be appointed by the Board of Selectmen. Thompson's suggestion was that the new group be given the title of "Deep River Town Hall

Auditorium Restoration Committee." Following a lengthy discussion Thompson presented the following excerpts as a motion, with second by Smith:

1]. Submit to a Deep River Town Meeting the following resolution:

RESOLVED: the Resolution approved at the Deep River Town Meeting of February 25, 1981, the text of which appears below, is hereby rescinded:

"To adopt a resolution giving the Deep River Town Hall Restoration Association, Incorporated, authorization for restoration of the Deep River Town Hall in substantial conformity with plans prepared by Luchs, Beckerman & Bird, of Glastonbury, Connecticut, to the extent that funds become available for such purpose, and the authority to monitor the maintenance, upkeep restoration and alteration of said building."

All authority granted to the Deep River Town Hall Restoration Association, Incorporated, is withdrawn.

- 2]. Create an administrative structure to replace the Deep River Town Hall Restoration Association, Incorporated, which will include:
  - a. Creation of a committee to be called the Deep River Town Hall *Auditorium* Restoration Committee (DRTHARC). The DRTHARC is authorized to oversee, and to arrange for the completion of the restoration of the Deep River Town Hall Auditorium, to the extent that funds are available.
  - b. DRTHARC membership will consist of a maximum of eleven (11) members who shall be appointed by the Board of Selectmen, with each to serve a two-year term. Approximately half of the initial members shall have one-year terms.
- 3]. Create a special fund to be titled Town Hall Auditorium Restoration Fund.

### <u>Audience of Citizens - Any Other Business to Come Before the Board</u>

Rich Strukus question why Constables, specifically Ray Sypher, who works full time, must be re-appointed annually. Thompson had information with him concerning this issue, and explained that the three officers were, according to State statutes, properly trained and certified. Smith stated that most towns had done away with the appointment process, and that now that the Board of Selectmen had all necessary information the ordinance would be rescinded.

Strukus also asked about the status of the Village Street Bridge. Smith noted that all approvals have been given and that bids will be advertised within a month.

John Greene had several questions concerning the Restoration issue. All were answered to his satisfaction.

Thompson moved, Smith 2<sup>nd</sup>, to adjourn at 7:25 pm.
