

BOARD OF SELECTMEN

DEEP RIVER TOWN HALL

Regular Meeting - August 13, 2013

Attendance: Selectmen Dick Smith, Dave Oliveria, Angus McDonald; also present: Margot Hilfinger, Rich Strukus (*vidiography*).

This regular meeting was called to order at 7:06 pm by Dick Smith.

Minutes: Regular Meeting – July 23, 2013

Oliveria moved, 2nd by Smith, to approve the minutes of the regular meeting of July 23, 2013. McDonald abstained.

APPROVED 2-0

<u>Discuss & Act on Sale of Fire Department 1976 Oshkosh Custom Platform Ladder Truck:</u>

Smith reported that the only bid received by the Board of Fire Commissioners was \$9,100. After brief discussion McDonald moved, Oliveria 2nd, to accept the offer of Killingworth resident John J. Kuzminski, a collector of fire memorabilia and vehicles.

Discuss and Act on Additional Appropriations and Transfers:

NOTE: the Selectmen remained in session during the Board of Finance meeting so the two Boards could discuss and act jointly on additional appropriations and transfers for Fiscal Year 2012-2013.

During the joint meeting Smith distributed a memorandum, together with supporting documentation, detailing over-expenditures, additional revenues and unexpended budget lines. Regarding the memorandum's final entry, **Elementary School**, Smith explained that he expects to receive a final accounting from Regional District #4 Business Manager Garth Sawyer shortly. Following the presentation by Smith, McDonald moved, Oliveria 2nd, to approve the necessary adjustments as presented in the First Selectman's memorandum.

APPROVED 3-0

Smith's memo in its entirety is attached to these minutes.

Audience of Citizens - Any Other Matters to Come Before the Board:

Margot Hilfinger asked for an update on the sewer expansion planned to serve the remainder of Kirtland and River Streets (including all streets that intersect with them). Smith stated that he had signed all enabling documents at a meeting with representatives from the United States Department of Agriculture. The USDA has awarded the town a grant and long-term low-interest loan to fund the project.

Hilfinger also asked about the \$400,000 Small Town Economic Assistance Program (STEAP) Grant received recently to fund extensive additions and enhancements to Plattwood Recreational Park. Smith briefly outlined the planned upgrades, and stated that he expects the work to be completed by December 31, 2014.

Oliveria moved, 2nd by McDonald, to adjourn at 8:30 pm.
