Regular Meeting - April 22, 2014

<u>First Selectman's Note:</u> Topics discussed and acted upon at meetings of the Board of Selectmen are often better understood in their historical context. Audience of Citizens - Any Other Matters to Come Before the Board:

Budget: Margo Hilfinger asked for an update on the Fiscal Year 2014-15 budget. Smith asked to postpone discussion until 7:30, when the Board of Finance meets, so discussion could include members of both boards and all those present.

Scheduling: Hilfinger also asked when the town budget public hearing and referendum would be held. Smith replied that the public hearing is scheduled for May 6th, and the Annual Town Meeting would be on May 19th. Both will be held in the Town Hall Auditorium. Following discussion, the Board of Selectmen set May 27, 2014, from noon until 8 pm, for the Budget Referendum. It will be held in the community room of the Public Library.

Mill Rate Increase: The Board of Finance has set the mill rate for FY 2014-15 at 25.90, which represents an increase of 0.85 of a mill over the current rate. The First Selectman has prepared a listing of the amount of the proposed increase for all Deep River properties. Residents are welcome to call the Selectman's office to learn the effect on their property.

Due to the cost of holding referendums, recent budgets with no increase or a minimal rise have been decided by paper ballot at the Annual Town Meeting. As noted at their previous meeting, the Board of Selectmen agreed that due to the mill rate increase this year a referendum would be appropriate.
