#### Replacement of HVAC Units—Deep River Elementary School & Public Library:

Smith advised the Board of Selectmen that the Town had received two bids for the replacement of a York ten ton capacity rooftop cooling unit at the Elementary School and a 15 ton capacity Trane cooling unit at the Library:

Daniels Energy	\$41,000.00
NEEC	\$42,106.84

The legal advertisement specified that the new units be identical to the present equipment, insofar as manufacturers' upgrades would allow. McDonald moved, Oliveria  $2^{nd}$ , to award the bid to Daniels Energy, pending Smith's confirmation that the equipment meets the Town's specifications.
