The meeting was called to order by Chair Grow at 7:01p.m.

Principal's Update

Assistant Superintendent's Report

Ms. Martineau gave a brief update. Strategic Planning for K-12 Curriculum is happening. This group will prioritize for next year. There is consensus that the focus should be on the critical thinking quadrant. There is excitement for the strategic plan and how we can impact student learning long term. Curriculum is changing to provide opportunities that are authentic so students are able to apply their learning. The Math pilot has been successful and we are preparing for the implementation. There will be a two day professional workshop in August. Grade Six is focusing on next generation science and working closely with 7th and 8th grade teachers. A decision was made to focus on the integrated model which will move us forward.

We have 30 Chinese students visiting this summer for two weeks in July. Host families will be needed. Valley Regional students will be international ambassadors. Information is available on the website.

ISUPERINTENDENT'S REPORT

District Update - Information and Communication

Dr. Levy noted that our district has contracted with Spiral International to contract for up to four Chinese students to attend school for the fall. We are seeing many students interested in international studies. We currently have trips to France and Spain and this is an opportunity to have a relationship with China. This is budget neutral. Dr. Levy discussed the manufacturing program. This program will expand next year. There will be a meeting with the Department of Labor and the Commissioner of Education to discuss expansion of this program. The students who are part of this program will receive an advanced certificate of manufacturing. This would be an additional certification along with their diploma. The program with Whelen Engineering is full every semester. A Therapeutic Program will begin next year at the high school to serve the needs of our students who have social and emotional challenges. The capacity is 10 and only open to students in our district. It is an exciting time across the district. Dr. Levy thanked everyone for their work on the budget.

Discussion and possible VOTE to renew the *Agreement Concerning the Establishment and Operation of an Interim Collaborative Preschool Program dated February 13, 2008. The Original contract expires June 30, 2012 per agreement may be renewed in 1 year increments upon agreement of all signing parties (Boards of Education for Chester, Deep River, Essex and the Regional Supervision District Committee) no later than June 30, 2017.*

Upon a motion made by Tracy Dickson and seconded by Miriam Morrissey the Deep River Board of Education unanimously **VOTED** to extend the site of the preschool for one year.
