<u>Superintendent's Report – Richard Forristall</u>

The lawn is mowed and the flags are getting set out at the grave sites. The cemetery is in good shape for Memorial Day.

Top soil was delivered and stored behind the office. Anything dug up will be dumped in the section formerly used for dumping brush and boulders.

V. Financial Statement – Jayne Mather

Jayne Mather presented the financial report as of April 30, 2015, the Association's year end. Actual revenues were \$105,172 vs. the budget of \$107,310. Expenses were \$73,358 vs. the budget of \$109,557. Operating the Cemetery with fewer staff resulted in considerable savings in payroll, benefits and fuel. Plans are to purchase needed equipment (a leaf sucker, walk-behind mower, back pack blower, and a 20" chainsaw) and maintain existing equipment during the next fiscal year.

A motion was made to approve the financial statement as presented for May 1, 2014 to April 30, 2015. This was seconded and approved.

A motion was made to approve the proposed budget as presented for May 1, 2015 to April 30, 2016. This was seconded and approved.
