Chairperson, Janice Kmetz, called the meeting of the Deep River Parks and Recreation Commission to order at 7:37 pm on Wednesday, December 14th at Town Hall. Members present were Janice Kmetz, Mary-Elizabeth Massey, Carol Jones, Sarah Kateley and Kevin Crosby. Audience of Citizens- There was one. Mr. Jim Godsman representing the Dry Pants Model Yacht Club spoke to the commission regarding the use of the pond at Plattwood Park in 2012. He presented an application for park use for three separate days and times of weekly sailing/racing sessions and also spoke to the commission about holding a regatta at the park. The regatta would be open to all and they anticipate that about 25-35 boats from around Connecticut would enter. They will charge approximately \$20.00 per boat but haven't decided on the exact entry fee as of this date. The regatta would be held the weekend of May 18^{th} - 19^{th} 2012.

Treasurer's Report- Discussion on recent expenses due to the holiday stroll event. This year the P & R budget was used to pay the fire police who were responsible for directing traffic. Next year, it was thought to advertise Santa's arrival for 6:00 as he was ready to go earlier and waiting at the fire house. Boy Scout Troop 13 provided 7 scouts who were on hand helping out for the evening.
- n. Basketball: The teams have been chosen and practices have started. The hoop extenders for the two hoops at DRES were ordered and have arrived. They will be installed this Saturday, December 17th by the town crew.

Other Old Business:



New Business:

Discussion regarding the use of Plattwood Park by The Dry Pants Model Yacht Club ensued. Kateley made a motion to allow the Dry Pants Model Yacht Club to use the pond at Plattwood for their weekly sailing sessions and also to allow the use of the pond for their regatta in May. The Park usage fee was reduced to \$75.00 and no fee will be imposed on the regatta unless the size of the regatta exceeds 35 boats. Crosby seconded the motion and it was carried.

Jones presented details of a photography class to be run by professional photographer, Steve Nadler. The class would run for 6 weeks, 3 hours each week and begin in April. The cost will be \$125.00. Jones will look into using the community room at the DR Town Library for the class. Jones is also working with Donna at the new fitness center located in town to set up a Zumba class at a reduced introductory price. Another session of the safe boating class will be held in the early spring. Jones has spoken to Pro Marine Education about running the class again. Also, in the works is a possible learn to kayak class and a celebrity run basketball clinic. Jones will send out all the details in an e-mail to members.
