

Town of Deep River Parks and Recreation Commission Meeting Minutes

June 10, 2015

The meeting of the Deep River Parks and Recreation Commission was called to order by Chairperson Justin Waz at 7:08 pm, on Wednesday, June 10, 2015 at the Deep River Town Hall. Secretary's Report- An amendment to the Meeting Minutes of May 13, 2016. The Parks and Recreation Commission had made the recommendations regarding the number of fertilizer applications (3) needed for fields A & B at Devitt Field. The Commission also notified Mr. Grabowski that historically the costs for fertilizer application had been shared. Also, the playscape for Devitt's Field has not been ordered. Motion to accept the Secretary's Report was made by Scholfield and seconded by Woodcock. The motion passed unanimously.

Treasurer's Report-A motion to accept the Treasurer's Report was made by Scholfield and seconded by Woodcock. The motion passed unanimously.

Old Business:

a. Carnival-The Schedule is as follows: Thursday, June 18 5-10pm, Friday, June 19 5-10pm and Saturday, June 20 12-10pm. Commission volunteers are scheduled for various duties beginning Thursday, June 18 at 7:30 am and ending Sunday,

The Commission voted to have Jones address our concerns with the owners of Simons. Jones also keeping a file on all correspondence regarding Simons at the Landing. The Gazebo still needs to be repaired.
