- 2. <u>Approval of Minutes</u>: A motion was made by Janet Edgerton and seconded by Leigh Balducci to approve the minutes of the regular meeting of March 17, 2016 with an amendment to Election of Officers to complete the last sentence to read "The clerk will forward the self nomination forms to the Commission members for preparation of the ballot for action at the next regular meeting." Voted Unanimously.
- 3. Payment of Bills: No bills were received.
- 4. <u>Correspondence</u>: Secretary Janet Edgerton noted receipt of the following correspondence: (a) Copy of letter dated April 20, 2016 from ZEO Jefferson to Robert Grieder regarding complaint received of construction equipment being used and stored and caged animals on property at 12 Lords Lane; and (b) ZBA minutes of meeting held on April 19, 2016 regarding application for 53 Essex Street.
