Town Hall

A **public hearing** of the *Deep River Planning and Zoning Commission* held on Thursday, January 17, 2019 at the Richard H. Smith Town Hall Auditorium was called to order by Chairman Bruce Edgerton at 7:02 p.m. Members present: David Basilone, Anthony Bolduc, Bruce Edgerton, Janet Edgerton, Jonathan Kastner, Jane Samuels, Ben Whelan, and Alternate Christopher Desrosiers. Also present: Cathie Jefferson (Zoning Enforcement Officer), Nancy Howard (recording secretary), David Tycz (Commission Attorney), and audience of citizens.

PURPOSE: Continuation of public hearing to accept evidence for or against, written or oral, approval of proposed Commission sponsored amendments to the Deep River Zoning Regulations to allow floating districts in the R-80 and CIP Districts for Landscape/Nursery Services and Contractor's Business and Storage Yards.

Presentation by Commission: Chairman Bruce Edgerton made a presentation for clarification to the public in regard to editorial comments that had been published in the newspaper.

ZEO Cathie Jefferson made a presentation of the proposed regulation amendment. The Commission started looking at the subject over a year ago. The floating district came about as a result of an application received for an overlay zone and there were concerns about how well it fit on a certain property. The floating zone would not be allowed for all districts. Existing uses are taken and put in the floating district, which would be more restrictive. The tool is a three part process and is more restrictive. For a proposal in a floating zone, the proposal would come before the Commission and if approved, an application would then be submitted to determine if the use is appropriate for the piece of property. At that point a sign would be posted on the property and a public hearing would be held on a special permit application for the proposed use. Existing uses were considered that could use more oversight. Regulations from Madison, Clinton, Middletown and Old Saybrook were reviewed. She noted that the proposal would offer greater transparency on uses that are already allowed.
