- 1. Meeting Convenes at 7:45 p.m., Deerfield Municipal Offices.
- <u>Present</u>: M. Gilmore (Chair), C. Shores Ness, J.P. Paciorek
 <u>Absent</u>: B. Kubiak
 Also in Attendance: P. Sloan, T. Fydenkevez.
- 3. There were no public comments.
- 4. The Board of Selectmen noted that they were late beginning this meeting due to a budget review meeting with the School Committee.
- 5. The Board also updated everyone on the Bird Flu epidemic. Residents are reminded to practice good personal hygiene (i.e., hand washing, etc.) and to continue to take responsibility for personal preparedness.
- 6. The Selectmen discussed the following items.
 - A. P. Sloan updated the Board on the FRCOG efforts to create a Scenic Byway along Rt. 116. The Board voted to send a letter of support of this project using the Conway support letter as a template, but with the change that a scenic byway start at the Sunderland Bridge, turn right onto Sugarloaf Street, continue along Elm Street to Rt. 5 & 10 and follow through to Rt. 116.
 - B. The Board of Selectmen met with Sunderland Selectmen T.
 Fydenkevez. They voted to go into Executive Session under MGL Chapter 39, Section 23B #3 to discuss Union #38 Contract Negotiations; by rollcall vote of M. Gilmore, aye, J.P. Paciorek, aye, C.S. Ness, aye, at 7:55 pm. The Board then returned to open session at 8:27 pm; M. Gilmore, aye, J.P. Paciorek, aye, C.S. Ness, aye.
 - C. J.P. Paciorek motioned to approve the following list of permits, C.S. Ness seconded, unan. approved all except B. Gilmore Home Business Renewal (2-0-1), wherein M. Gilmore abstained.

 - B. The Superior Court Order issued regarding 97 Stillwater Road was read into the record.
 - C. The Board accepted with regret, P. Kuzdeba's resignation from the Recreation Committee.
 - D. The Selectmen will attend the meeting at Sunderland Town Hall on March 8, 2006 to discuss the Union #38 FY08 Budget. Requested that K. Warren advise the Capital Improvement Planning Committee, Finance Committee, and the Town Administrator of the meeting and forward RSVP from the Board to M. Nartowitz.
