1. Meeting convened at 7:30 p.m.

3. Selectmen's Comments / Announcements

- Mrs. Blanche Hukowicz to receive Boston Post Golden Cane award – Mr. Paciorek made a motion to sign the Golden Cane Award and make a presentation to Mrs. Hukowicz at 10:30 on Wednesday, April 11, 2007. Ms. Ness seconded the motion. Vote passed unanimously (3-0).
- Second Annual River Road "clean up" day scheduled for Saturday, April 21, 2007 from 9:00 a.m. – 11:00 a.m. with a potluck luncheon to follow. The scheduled rain date is Sunday, April 22, 2007.
