Local Cultural Council Meeting November 12, 2013

Present: Reba-Jean Shaw-Pichette, Carol MacBurnie, Jack Cavacco, Julie Cavacco, and Candace Bradbury-Carlin

The meeting was called to order at 6:00 pm at the Deerfield Town Hall, 8 Conway Street.

Reorganization: Candace Bradbury-Carlin was welcomed as a new member. In a motion made by Jack, seconded by Candace, and voted, Reba-Jean was elected Chair. A motion made by Jack, seconded by Candice, and voted, was to also appoint Reba-Jean as the official signatory for Council business.

Reba-Jean explained the committee now has its own e-mail address and a mail box, so individual member personal emails and phone numbers do not need to be disclosed. There has been a problem in the past of applicants and others making unpleasant calls to members.

2013-2014 Applications: The allotment from Massachusetts Cultural Council is \$4,250.00, an increase from last year. There were 38 new applications totaling \$20,988 in requests.

Reallocation of funds: A list of projects for which reimbursement requests have not been received. Reba-Jean said usually the committee waits until January before reallocating unused funds from the previous year's awards. There is one award from 2011 that appears not to have been expended. (David Bates - \$250.00) A motion was made to release this money, making it available for reuse. A motion was made by Reba-Jean, seconded by Jack Cavacco, to reserve 2013 funds; \$25 – ACT, \$25 – First Church, \$75 – Tilton Library Upcycling, and \$150 PVPA Children's Theater until at least December 31,2013. The vote was unanimous.

In order to be considered applicants need to show that they have a venue, the Council does not hire performances. A second concern is that the request is not greater than the cost of the activity. Priority is given to local non-profits, especially those free or discounted to Deerfield residents. The Council reviewed each application, noted letters of support, and agreed to support the following:
