### **New Business**

- 1.With the full approval of the DHC members, the meeting was temporarily turned over to Betty to deal with the yearly reorganization of the Historic Commission. Henrietta Kocot was nominated again for Chair of the DHC. Ken Schoen was nominated for Secretary. Both were approved unanimously. The position of bookkeeper was removed as per town instructions.
- 2. Betty reported on meeting with the Town Accountant re the DHC Budget.

It was confirmed that we can spend funds as needed and not necessarily for the allocated items, so long as we do not exceed our budget. We also approved a budget reduction by the town to \$1,975 which reflects the \$500 projected legal expense being Town expense rather than Commission responsibility.

### West Deerfield Project

Jane reported that -Bernie Kubiak says we can proceed.

David Glassberg of UMass Public History toured the Sugarloaf Cemetery and drove by the West Deerfield cemeteries with Jane. The students from UMass will 1) conduct a new survey of Sugarloaf St. cemetery, 2) Create maps with GIS of each stone, and 3) all information will be uploaded onto the Deerfield/DHC online site.

# Trees and Hedges

Jane asked Sean from Highway Dept. about cutting back the hedges at the Baptist Cemetery in West Deerfield. And showed him a estimate cost from Jim's Tree service for the removal at Sugarloaf St Cemetery of one of the large trees that "sprouted" there. It is not a healthy tree. He said he thought it would be best to lump all the tree work together and that he would be taking care of this. The wood white picket fence at Pine Nook Cemetery was replaced by the Highway Dept. with a plastic fence of the same design.

## 2. Historic Inventory

Marilyn handed out an inventory list of Shirley's work. They have done very impressive work and the project is moving along well. A letter will be sent to property owners in the catchment area of the Historic Inventory Project and a public information meeting will be held on October 25<sup>th</sup> at 7 p.m. It will be filmed for public access TV.

## 3. Street Scape Project

Henrietta reported that Nelson Nygard got the grant and is working with the Cecil Group in Northampton. Jane will see if the proposals done years ago by the Conway School of Landscape Architecture can be located.
