### **OLD BUSINESS**

#### -Civil War Memorial update

John reported on a meeting he recently had with Katherine McKay from the Alumni Relations Office at Deerfield Academy. She said that an alumnus (anonymous at present) had created a Old Main Street Preservation Fund and was interested in helping support the conservation and repair of the Memorial. This could happen within the next few months, removing the serious liability and allowing the Commission to use its recently-voted CPA funds to focus on the repair and conservation of the pedestal once the soldier had been taken down and safely stored,. Documents for putting the pedestal work out to bid will be prepared in conjunction with the Town Administrator. The Academy will be put in touch with Francis Miller, a conservator who has already done an evaluation of the monument. A plaque recognizing the OMSPF will be incorporated into the restored wrought iron fence that will eventually be returned to its place surrounding the monument.

## -Sugarloaf St update.

Jane made a full report. We have until July 1, 2016 to complete the work. Jane composed and sent Kayce a full accounting of what the DHC goals have been for this project along with many photographs useful for the RFP (or whatever they call the form) Next steps belong to Kayce.

## -Albany Rd Cemetery update

Childs Family has paid for 17 stones. The donor noticed that many adjacent trees had dead branches. DPW was alerted to have them removed before restoration work begins. Kai Nalenz was hired for the restoration job and he will be finished by the end of July. Bridgett will be passing by to check on progress. Some of the Childs family stones are in level 1 category and will be then removed from our next proposal for Albany Rd Cemetery restoration.
