## III. VESH Inc. (Veterinary Emergency & Specialty Hospital)

Applicant requests a special permit, variance or whatever relief is required to build Phase II of a multiple building commercial development on Rte 5 & 10 in Deerfield (C-III district).

Present are petitioner Steve Upton, Brenda Salyer, VESH member, Kirstin Losert, DVM and Erika R. Mueller, DVM. Steve present project Phase I (first building). Two additional structures will appear in Phase II.

Traffic study and letters from Deerfield Police and Fire Chiefs showing no safety concerns are presented to board along with support letter from local veterinarians.

There will be no outside kennels and the business will operate solely as an emergency center with walk-ins welcome without referrals. The optimum number of employed personnel will be 25.
