## **Call to Order**

5:30pm: Chairman, Steve Barry called the meeting to order.

## **Opening of Bids**

## Propane Gas - 4,000 gallons approximate:

Irving Oil - \$1.7399/gal fixed or a current variable rate of \$1.723/gal

- Rymes \$1.54/gal
- Palmer Gas Ermer Oil \$1.60/gal fixed or current variable rate of \$1.65/gal
- Fred Fuller \$1.545/gal
- Hartmann Oil \$1.69/gal

Motion – Vice Chairman O'Neal moves to award the contract to Rymes

Discussion – Vice Chairman O'Neal pointed out that this was the lowest priced bid and that Rymes has supplied the Town with propane for the past three years. Selectwoman Hutchinson asked what the current contract cost is and Mark will find that answer out.

## Heating Oil - 24,000 gallons approximate:

- Irving Oil \$3.361/gal fixed or a current variable rate of \$3.331/gal
- Rymes \$3.36/gal fixed
- Palmer Gas Ermer Oil \$3.389/gal fixed or a current variable rate of \$3.349/gal (\$0.15 discount)
- Fred Fuller \$3.195/gal
- Buxton 30,000 gallons @ \$3.319/gal or a variable rate of \$0.25 over the Sprague Energy Posted Price
- Hartmann Oil \$3.33/gal fixed or a variable rate of \$0.215 over Sprague Energy Posted Price

Vice Chairman O'Neal expressed that though the Town has had issues with Fred Fuller in the past, that their bid is so much lower than the others, it may be worth having him in to discuss. Mark spoke that in the past when contracted with Fred Fuller the Town did run out of Heating Oil several times, and that when they contacted the vendor in June to have the tanks topped off the delivery was refused. Selectwoman Hutchinson asked how long ago this was and Mark answered three years. Leslie suggested delaying awarding of the bid and she will communicate Town's concerns with the lowest bidder to allow them an opportunity to reply. Selectwoman Hutchinson suggested requesting current references. Mark added that all vendors need to understand the small size of the tanks in Town that require weekly filling from December to April. Leslie will reach out and the Board will revisit at its next meeting.

## Diesel Fuel - 8,000 gallons approximate:

- Buxton \$0.29/gal over Sprague Energy Price
- Hartmann Oil \$0.215/gal over Sprague Energy Price
- Irving \$0.117/gal over Sprague Energy Price additionally offered discount to Town Employees on Residential Diesel and Propane
- Rymes \$0.23 over Sprague Energy Price

## **Scheduled Appointments**

## Mark Tibbetts - Bid Awards: South Fire Station Project

Chief Tibbetts informed the Board that he has received a bid for the work to be done at the South Fire Station that is approximately \$3,000 less than the other contractors. He and Selectman Pitman met with the individual do go over the work specs and his proposed price, he has received mixed feedback from the references provided. While the Town has a great history and relationship with Gary Anderson, Mark understands the Town's sensitivity to cost and as a result would recommend awarding the South Station work to the lesser priced contractor – E. Guimond Construction out of Bow, NH. The expectation is that the work on this project will be closely monitored and, if all goes well, they will be allowed to continue with work to be done on the GBW Project. Mark is raising the issue before the Board at this time because he is looking to order siding in bulk, by doing so he will receive a price reduction of \$2,904.

Selectwoman Hutchinson asked what would happen if the work is not done well to which Selectman Pitman responded that he would not be paid. Mark noted that the contractor has requested 50% of the cost – or \$3,998 – to be paid up front. The Board was comfortable with Mark's recommendations.

Motion - Selectman Pitman moves to approve \$7,796 to E. Guimond Construction of Bow, NH

Second - Selectman Robertson

Discussion – Vice Chairman O'Neal asked when the initial 50% would be due and Mark answered upon start, with the balance to be paid upon completion. Vice Chairman O'Neal asked if the dollar amounts of the specs had been revised to include the reduced siding costs and Mark answered yes.

### - AVITAR Response Regarding Willwerth Property on Northwood Lake

The Board is in receipt of a written response from AVITAR regarding the valuation of the Willwerth property. AVITAR indicates that the valuation is accurate, despite the occupancy restrictions and suggests that making an adjustment based on limited

occupancy could open the Town up to numerous other reductions of value on seasonal properties. AVITAR recommends no change to the valuation of the property. Selectman Robertson indicated that the Board historically relies on the opinion of AVITAR as it feels it is prudent to follow the advice it is paying for. At this time the Board is unable to help the Willwerth's regarding the assessed value of their property. Mr. Willwerth asked if the land was sold, would the buyer be able to get a variance to build. Chairman Barry answered that the Willwerths would need to contact the ZBA to find that out.

#### - 2010, 2011 and 2012 Tax Abatement - Harry Jackson, 143 Nottingham Road

Town Administrator Leslie Boswak explained that Mr. Jackson has paid taxes on a piece of land that does not belong to him as a result of an error made by the tax map company. This abatement request is to refund the amounts paid in error.
