#### **Veasey Park Commission**

Travis McCoy of the Veasey Park Commission updated the Board that the group is working on the non-motorized launch and has a number of questions and concerns to be discussed. They are concerned with how to differentiate between visitors of the beach and the launch and about how they will control non-residents who launch at the boat ramp and exit at Veasey to use the facilities. There is a concern that staff will have no control over who is coming into the park, especially when there are no guards on duty and in the season before Memorial Day and after Labor Day. Additionally, there are outstanding questions about what finances are available for the necessary clearing of trees and expansion of the parking lot, will this be pursued by way of a Warrant Article.

Chairman Barry responded that, once the Commission has put together a plan of action, the work may be suitable as an Eagle Scout Project or some other volunteer endeavor.

Travis McCoy raised additional concern with the amount of boat traffic already in the proximity of the swim area and the discarded tackle that has been found at the floor of the swim area. He asked whether the Town might consider some sort ordinance to extend the distance boaters may be to the buoy lines. Vice Chairman Pitman responded that it is a State Law that governs how close watercraft can be when traveling less than 6 mph. It was suggested that the Commission consider installing a second line of buoys outside the current lines to give a better buffer.

It was agreed that the Commission will return with a more detailed proposal of the scope of work and estimated costs. Selectman Robertson reminded that the intent of the footpath is to allow access only for boats/paddle boards that are able to be carried by the operator.
