# **Monthly Report - Highway Department**

Road Agent Mark Young updated that, with the slow Winter, the Department has been working on painting and organizing equipment at the new storage shed. Cold patching and grading of the dirt roads has been a work in progress. All roads have been posted for weight limits. To date, approximately 60% of the Salt, 50% of the Sand and 50% of the Winter Contractor budget lines has been spent.

## **Monthly Report - Fire Department**

Chief Tibbetts spoke that he has been reflecting some time on a new idea and would like to propose that the Town name the stretch of Stage Road that runs past the Fairgrounds as the "Chief George E. Clark Memorial Highway". The Board was in support of the idea and Chief Tibbetts added that he would like to plan for a dedication ceremony on the Wednesday before the Fair opens. Chief Tibbets also reported that he will be leaving Friday, March 11th for vacation, returning March 25th. The Raymond Fire Department has agreed to automatically respond to any calls between 7a and 4p while he is away.

### **Northern Pass**

Joanne Bradbury, with the Northern Pass Action Committee asked that members of the Board attend the Public Hearing scheduled for March 16th at 5p at the Fairgrounds. The Agenda has scheduled 4 minutes for a representative from the Board to speak.

Fred McGarry spoke that the Site Evaluation Committee ("SEC") will be reviewing sites impacted by the installation of towers and recommended that the Board put forward a letter to the SEC asking it visit a list of impacted locations. Deerfield Center, stretches along Nottingham Road and the properties abutting the substation were identified for inclusion. Erik Berglund described the Wetland Permit that has been obtained for the Project and described that the Project includes plans for a new substation, closer to Nottingham, on approximately 5 acres of land. He spoke that it is unclear how long construction will take.

The Committee publically thanked Select Woman Hutchinson, at this her final meeting as a Member of the Board, for her work and participation with the Town's response to the Northern Pass Project.

# Correspondence

# **Scheduled Appointments Continued**

Mr. Duclos appeared before the Board regarding the property at 123 Nottingham Road and the Town's plans to place the parcel for auction in April. Mr. Duclos spoke that he has resided at the property and proposes to make arrangements to pay the back taxes and purchase the property. The Board agreed that the Town Administrator will contact the Town's Counsel to determine what the legal process for moving forward with the proposal would be. An answer will be provided to Mr. Duclos at the Board's next meeting in two weeks.

### Town Administrator's Report

J. Foisy reported that work has continued with the Southern New Hampshire Planning Commission on the Regional Purchasing project. The Town is currently paying an electricity rate of \$0.099 and the cooperative rate through the SNHPC would be \$0.075. The current contract runs through December 31st and so J. Foisy is looking into the details of termination in order to achieve the lower rate.

The St. Jean auctioneers have been contacted regarding the Town's properties under lien. They are currently conducting site visits and will be returning information to the Town shortly.

Finally, J. Foisy reported that an issue has come up with the work at the George B. White Building as the foundation has been found to be solid concrete, as opposed to blocks. Mark Tibbetts is working to find a contractor to remove.

## <u>Unfinished Business</u>

Selectman Robertson asked that, when Chief Tibbetts returns from vacation, that the Department begin strategizing and holding the necessary work sessions on both facility and personnel needs. He spoke that Deerfield is one of the few Towns currently without full time Fire and Rescue staff on call during daylight hours and would like to open the conversation about bringing on Full Time Employees. Selectwoman Hutchinson has spoken recently with the Representatives of the UNH "NH Listens" Program and has plans to discuss Deerfield's needs at an upcoming meeting. More information will be forthcoming.

Selectwoman Hutchinson reminded everyone that the Beard Growing Contest will be finalized April 16th in conjunction with the Town Wide Clean Up. Reminder emails with details will be coming to the Board shortly.

Chairman Barry, together with Vice Chairman Pitman and Selectmen Robertson and Shute thanked Selectwoman Hutchinson for her service to the Board. Selectwoman Hutchinson expressed her appreciation of the opportunity to serve and the experience.
