2017 Budget Review

Information Technology

The Information Technology budget was presented with a decrease of \$310. J. Foisy recommended an adjustment to Steve Jamele's hours from 20 to 24 and a change of rate to \$33.58/hour. The recommendation would raise the Department budget from \$49,160 to \$54,098. The Board had no objections, there were no other changes.

Municipal Budget Committee

The MBC budget was presented with a \$32 decrease.

Welfare Administration/General Assistance

Denise Greig spoke that the recommended Budget is largely unchanged from 2016. J. Foisy recommended increasing the Welfare Administrator Salary Line to \$25,688.47, a \$700 increase. There were no objections and no further questions.

Agency Health and Social Services

Denise Greig spoke that there were no changes expected to the budget. Two agencies have merged; the other programs are level funded. The Board thanked D. Greig for her work.
