Town of Deerfield BOARD OF SELECTMEN October 24, 2016 MINUTES

Call to Order

5:30p - Chairman Barry called the meeting to order.

Present: Stephen Barry, Chairman; Richard Pitman, Vice Chairman, Andrew Robertson, Jeff Shute and Fred McGarry, Selectmen

Pledge of Allegiance to the Flag

Chairman Barry asks all to rise and pledge allegiance to the Flag.

2017 Budget Reviews

Town Clerk/Tax Collector

K. Barry reported that he has proposed a 2.5% raise for the Deputy Town Clerk/Tax Collector. The other increase in the budget was due to the higher mileage reimbursement rate. In total the budget is \$7,500 higher. It was noted that the Town Clerk/Tax Collector's salary was also raised due to the State's Overtime law.

Town Meetings and Elections

K. Barry spoke that 2017 would hold just the Deliberative Session and Town Meeting, as a result this budget has gone down \$2,800. He is seeking to add \$400 to the Vendor line so that a second hearing assistance system can be available.

Emergency Management

K. Barry spoke that the budget has decreased \$500 due to reduced diesel fuel costs. All other lines were level funded.

Highway Department

M. Young spoke that he has proposed a 2.5% increase for the Department Employees. Heating oil, gas and diesel fuel lines are all reduced. Road reconstruction plans for 2017 include resurfacing of Nottingham, Pleasant Hill and Coffeetown Roads. Selectman Shute asked whether the increase in the Overtime line was attributable to the 2.5% rate increase, M. Young confirmed yes. Selectman McGarry shared the praise he had heard for the Department's work on Nottingham Road.

Selectman Robertson noted that there are a number of proposed increases to Town Employee salaries and that the Board will need to take a broader look to discuss the best approach.

Review of Correspondence

The Town Administrator presented the Board with a list by Department of proposed Employee raises. Chairman Barry reminded that the Board will need to make a recommendation on the Town Administrator's salary.

\$532,363 is owed to the County.

Motion: Selectman Robertson moves to pay Second: Vice Chairman Pitman Vote: Yea 5, Nay 0, Abstained 0 - Motion Carries

The Property and Liability Program and Workers Compensation Program renewals were discussed. This is a multi-year contract running through 2017. The Property and Liability rate have gone down from \$49,553 to \$43,268, the Workers Compensation rate has increased from \$33,178 to \$36,496.

Town Administrator's Report

J. Foisy reminded that a MBC meeting was being held October 25th at 6:30. Selectman Robertson is unable to attend, J. Foisy will present the initial draft of the Town Budget.

The next Board meeting will be November 7th unless the Department of Revenue figures are available, in which case the Board will meet to set the Tax Rate. J. Foisy expects to have the Winter Contractor's contracts available for review and approval at the November 7th meeting.

Citizens Comments

Mark Duclos of 123 Nottingham Road spoke regarding a personal property situation. J. Foisy indicated that the Town has sent materials, certified mail, to the Attorney. The Town will follow up to ensure everything is in order.

Tom St. Martin of Candia introduced himself as a candidate running for State Representative in Rockingham District 2. Mr. St. Martin spoke that he was previously a Representative in 1993 and 1994, is the only Veteran running, and sees addressing the NH Opioid crisis as the State's primary focus.

Chris Roundy of Nottingham introduced himself as a candidate running for State Representative in Rockingham District 2. He described his background as an Attorney and spoke to the drop in funding for behavioral health services as an issue of his focus.

Budget Reviews Cont. - Library

E. DeCota read a statement regarding her time spent at the Library during her 35 years of service. During her tenure the Library has evolved from a one day (four hours)/week operation to now 6 days (37 hours)/week. She thanked the many volunteers, co-workers, community and Board of Selectmen for the wonderful time.

Regarding the budget, the Library has proposed adding an additional Part Time Aide, a 15 hour position so that it will be possible to always have two staff members on duty. She read a 2016 State of the Library detailing the several exterior and interior repairs that had been made. The Board thanked Evelyn for her service and had no questions concerning the Budget.
