Town of Deerfield BOARD OF SELECTMEN December 19, 2016 MINUTES

Call to Order

5:30p - Chairman Barry called the meeting to order.

Present: Stephen Barry, Chairman; Richard Pitman, Vice Chairman, Fred McGarry, Andrew Robertson, and Jeff Shute, Selectmen

Pledge of Allegiance to the Flag

Chairman Barry asks all to rise and pledge allegiance to the Flag.

Chairman Barry described that the Board will be going into a Non Public session to hold discussion on the tax assessing methodology in Deerfield with regards to the Northern Pass project with Attorney Whitley. The floor was opened for ten minutes of public comment.

Jeanne Menard expressed concern that Eversource is seeking to strike a deal with the Board in discussing property valuations and tax revenues behind closed doors. Selectman Robertson responded that tonight's discussion would be an initial feeling out process and that the Board had no desire to work out a back room deal. He spoke that the Board would not be discussing the Town's opposition to Northern Pass with Attorney Whitley this evening. Ms. Menard asked how the Board plans to take into consideration the impacts (visual and other) of the Northern Pass project when evaluations the tax revenue proposals. Selectman Robertson responded that the Board has no plan at this initial stage of the process. Ms. Menard asked why tonight's conversations needed to be held in a Non Public Session, Selectman Robertson responded that the Board intends to receive legal advice and feels that, at this stage, a Non Public would be best for Deerfield. Ms. Menard provided the Board with the Department of Energy's ("DOE") environmental impact statement regarding the visual impacts of Northern Pass to Deerfield. She noted that the DOE found the impacts to be unreasonably adverse and hopes that the Board will have this type of information top of mind when carrying out discussions on the Project.

**** spoke as a voter opposed to Northern Pass and urged the Board not to make a deal with Eversource. She spoke of Deerfield's strong defenses noting that there is still more testimony and responses to requests for data to be filed with the Site Evaluation Committee. She feels it is too soon to begin discussing settlement and cautioned the Board in its discussions with Eversource.

Harried Cady spoke that she is appalled that the Board has taken this position on a compelled speech issue. She feels that the power lines are quickly gone from sight when traveling past and does not see where use of the existing right of way will change the visual impact to Deerfield in any way.

Town of Deerfield Safety Policy

Chairman Barry described the Board's responsibility under the Policy to develop the program, provide the necessary resources and respond in writing to the Joint Loss Management Committee ("JLMC") recommendations. Based on 2016 incident data the JLMC recommends reminding employees that safety is the number one priority and to make available yaktrax for walking on slippery surfaces. The recommended 2017 benchmarks will be for the JLMC to work to share and promote safety policies, expanding outreach to each department. The JLMC completed a safety checklist of Deerfield properties. Multiple emergency light batteries had failed and were replaced. The JLMC recommended several improvements including addition of eyewash stations and leveling of the area around the GBW Basketball Courts.
