# Town of Deerfield BOARD OF SELECTMEN December 29, 2016 MINUTES

## **Call to Order**

5:30p - Chairman Barry called the meeting to order.

# **Budget & Warrant Article Reviews**

Chairman Barry spoke that the Town Administration payroll line will require an increase of \$14,035 to account for Jan Foisy's role through the Spring.

Selectman Robertson spoke that a member of the MBC, Kevin Verville, has expressed an interest in having a perennial Warrant Article put forward for Road Reconstruction without the naming of specific roads, the rest of the MBC seemed in general agreement. Selectman McGarry described the concern that, should Deerfield continue on the Road Reconstruction pace it has been, that the Town roads will end up in dire shape. Selectman Robertson did not feel he had the appropriate background information to propose a specific Warrant Article dollar amount without understanding the Road Agent's 5 year plan.

Members of the Board agreed to work over the coming year with the Road Agent to identify an appropriate dollar amount. Selectman Robertson suggested the forming of a Highway Committee to work on Warrant Articles for the 5 and 10 year Road Reconstruction plans in Town and to appoint a member of the Board to serve as Highway Liaison. The Board agreed it would like to have the Committee ind place at the end of January, start of February.

Selectman Shute noted a typo in Warrant Article #2, the amount should be \$67,540.

### **Fire Chief Mark Tibbetts**

Chief Tibbetts spoke that, having discussed with his wife and family, he has decided he will retire from his positions of Fire Chief, Building Maintenance Superintendent, and Winter Contractor effective December 31, 2017. He thanked the Board for its support of him over his 22 years of service. Chairman Barry thanked Chief Tibbetts and suggested that the Board begin to formulate a plan for how to fill the roles as soon as possible. Chief Tibbetts noted that the Building Maintenance position requires an individual be on call 24 hours/day. The Board asked Chief Tibbetts to compile a checklist for both the Fire Department and Government Buildings of tasks that he carries out and projects to be aware of.

# **Review of Correspondence**

The State of NH Meals and Rooms funds were received in the amount of \$228,194.

Notice was received from the NH Charitable Foundation regarding an award of \$50,000 in grant money from an Anonymous Donor Advised FUnd for the Marston Conservation Project. The Town Administrator will coordinate with the Conservation Commission to schedule a Public Hearing regarding the acceptance of any money.

## **Town Administrator's Report**

J. Foisy noted that she has received a phone call from Cindy with the State DOS Mooring Division regarding the mooring on Pleasant Lake in effect for property owners on the Lake for 2017.

### **Unfinished, Other or New Business**

Selectman McGarry spoke that the Southern New Hampshire Planning Commission is looking at its extended transportation plans. Two projects are on the plan for Deerfield, a 2030 bicycle lane installation and \$3M to redo the intersection at Candia Rd/Church Street set for 2031. Selectman McGarry noted that there is an anticipated surplus of \$25.5M in unallocated funds for the year 2023 that, if not committed to projects, will go be reallocated to other areas of the State. He suggested the Town form a Committee to propose projects that would be valid and useful along the Town's Highways, Selectman Robertson concurred, suggesting the junction of Routes 107 and 43 as one such project.

Selectman McGarry also noted that Chief Tibbetts had provided a response to his queries around the Fire Department. He asked for a copy of the response for review.

### **Citizens Comments**

Pete Schibbelhute volunteered to serve as a member of the Highway Department/Road Reconstruction Committee, noting that he feels it would be a great way to alleviate the "not my road" complex that many projects seem to meet. He echoed support for work at the Routes 107/43 intersection.
