### DEERFIELD CONSERVATION COMMISSION 1967 - FIFTY YEARS AND COUNTING - 2017 Meeting Minutes – August 21, 2017

At 7:05 pm Chair Serita Frey called the meeting to order.

**Education Grant Opportunity:** Guest, Ellen O'Donnell presented an opportunity for collaboration between the conservation commission and her 7<sup>th</sup> and 8<sup>th</sup> grade students at Deerfield Community School (DCS). Ms. O'Donnell was recently notified of new grant funding from the New Hampshire Association of Conservation Commissions (NHACC), jointly available to schools and conservation commissions, to partner on a conservation project that would not only be a hands-on educational opportunity, but also provide a benefit to the community.

Ms. O'Donnell provided the proposed plan details which included **performing wildlife and vegetation inventories and identifying habitats existing within a town forest.** Trail cams will be employed to confirm the types of wildlife surmised to exist within those communities. Students will use a land cover classification system to assign standardized codes to the land cover found within the various habitats on a property. They will then be able to compare the characteristics of Deerfield's forests with those of students in Finland and Germany. Students would also identify and create a plan to correct human impacts they discover, followed by a community action/celebration day. Members chose McNeal Town Forest (Blake's Hill Rd) and Dowst-Cate Town Forest (Nottingham Rd) as the areas the students would survey.

**DCC involvement would include setting up a community survey to collect publicly provided data** (surveys at trail heads, iNaturalist.org, Trails Club Facebook page and Forum postings). Deadline for the application is August 31<sup>st</sup>. Serita Frey will complete the DCC portion of the grant application.

Zoning Input: Sylvia von Aulock, Deerfield Town Planner & Executive Director, Southern NH Planning Commission (SNHPC), has requested input from DCC to possible changes in current zoning. For consideration is the addition of a "no disturbance" setback for wetlands; a natural, vegetative buffer zone within the setback. Current zoning provides for a "structural" setback of 100 feet from wetlands, but does not stipulate what may be within those 100 feet. Also for consideration is requiring contiguous acreage be used in determining the buildable area on any given lot (current minimum lot size in Deerfield is 3 acres with ¼ acre minimum buildable acreage). Kate Hartnett cited the importance of upland buffers to control the flow of pollutants down into wetlands, i.e. from fertilizers and pasture land. Ms. von Aulock has offered to prepare a matrix for Deerfield, comparing its current zoning with other communities, and Haley Andreozzi will send information on a statewide Wetland Buffer Working Group. Ms. von Aulock will be available for further discussion at the September meeting, after members have had an opportunity to review current zoning and proposed changes.

**Eversource Utility Maintenance Work:** Sherrie Trefry (Director of Energy & Environmental Services – VHB) and Kevin McCune (Eversource), both representing Eversource, presented aerial maps of plans for proposed replacement of insulators, and of several existing structures, at the Deerfield substation and within the Eversource ROW in Deerfield as part of Eversource's annual maintenance program on its 307 and C129 lines. It was questioned whether replacement of existing poles would be subject to the restrictions of the *Wetlands Conservation District*. Although the representatives state that a *Wetland Utility Maintenance*

*Notification* would be filed, and that Best Management Practices (BMP's) would be adhered to, **Kate Hartnett and visitor/resident Jim Page offered historical evidence of severe damage to sensitive wetlands resulting from previous work being performed in 2016 and 2017.** Mr. Page inquired about specific impacts to the project areas. A site visit prior to submitting the proposal and the work being done was suggested. Of note was the **inaccuracy of the aerial base maps (dated 2010 and 2011)** that show an area as currently forested, but that Mr. Page notes had been cut last year, resulting in destruction of vernal pools from skidders and backhoes. Ms. Hartnett felt that a *Wetland Permit* should be required; the project should not simply be part of a *Wetland Utility Maintenance Permit*. Visitor/resident Phil Bilodeau questioned if the work was actually in the permitting stage, since as an abutter, he had received notification dated August 17, 2017 that the work would begin "in the next couple of weeks...on the right of way on or near your property..." and would include the replacement of existing wood structures "...with new steel structures of similar size.". Representatives stated they would look into the members' and residents' concerns and complaints, and that the work was not related to Northern Pass.

Town Planner, Sylvia von Aulock felt that the project fell within a gray area of *Deerfield* zoning regulations for *Wetlands Conservation District* (Sec. 210) and that the existing conditions were not clear. After listening to comments from members and residents about past experiences indicating that BMP's had not previously been employed, Ms. von Aulock felt Eversource should come to the Deerfield Planning Board to obtain a *Conditional Use Permit*. Of concern are access, erosion control and past practices. Eversource needs to spell out the BMP's to be followed; that this work needs to be done correctly.

**Town Forest Inventory Project: Fred Borman, UNH Cooperative Extension, explained the goal of the project is to inventory all the town-owned conservation lands in New Hampshire**. DCC provided basic information on Deerfield's town-owned parcels which will be used to complete questionnaires for each parcel and tract. Data from the paper surveys will be input into a database which will also be shared with NH GRANIT (Geographically Referenced Analysis and Transfer System). DCC will be collecting additional data, as possible, relative to governance, stewardship, forest management, and intended uses. The data being collected will also be beneficial in updating the *Deerfield Open Space Plan*.

**Approval of Minutes:** A motion by Chair Serita Frey to approve the **minutes of the July 10<sup>th</sup> meeting** was followed by a second from Erick Berglund, and approved unanimously.

**Finance:** Erick Berglund reported that he has received **no updated information** on the balance in the Conservation Fund since the April report.

**Budget:** Erick Berglund asked members to review the **proposed budget for 2018.** Ben Minerd was asked if he knew of any un-reported expenses incurred for FY 2017 or anticipated for FY 2018 for the Trails Committee. Mr. Minerd will speak with Jim Deely to determine if \$200 will be sufficient for FY 2018. Haley Andreozzi suggested tapping resources available through *Stewardship Network: New England* and the *NH Trail Finder Project*. Ms. Andreozzi will forward links to the two programs.

**Membership:** Both **Haley Andreozzi and Ben Minerd** have been sworn in as DCC's two newest members, replacing Deb Campelia and Jim Deely respectively. Welcome Aboard!!
