### **REPORTS CHAIR**

DES Wetlands Bureau Complaint File#2007-01505.57.5 No. Shore Rd. No follow up by us was necessary. Residents invited back for follow up of Community Profile. We encourage and we welcome your participation on April 29<sup>th</sup> from 7pm to 8:30pm on the 3<sup>rd</sup> floor of the Derry Municipal Center. We had over 150 participants that voted on over 20 options at the Planning meeting. We were informed of emergency work being done on Sheldon Rd. Also the Acting Chair reported a phone call from a concerned citizen about trees being cut down at The Broadview Farm

After a long discussion with Mr. Wes Aspinwall about the sewer connection and the catch basins and who would be responsible for the shared driveway, it was decided that another site walk was in order when Ms. Ives, Chair and Mr. Dionne, Vice Chair would return from their work down south we would do another site walk. ### **COMMUNITY GARDEN EXPANSION PROJECT**

Mr. D. Wiley said the lots are all but taken and that we have been slowed down because of the brush removal and more brush has to be removed before we can move ahead. Mr. Paul Doolittle offered his new brush machine. The Commission voted unanimously to pay up to \$300 if any damage occurred and the Commission would also pay for the fuel. There are no brush machines available as everyone in town is renting them to clean up their yards after the December Ice Storm. Ms. Sarcione said she would call farmer Phil to see if he could help us and then have him contact D. Wiley as we have been working with Farmer Phil over this problem. Mr. Wiley also stated that he would like Farmer Phil to send us a bill. All were in agreement

### **OTHER BUSINESS**

Ms. Ferrante reminded the T.V. audience that we are all volunteers and anyone who would like to give us a hand over at Broadview Farm, to call Ms. Shelia Bodenrader at Town Hall. Mr. Rick Buzzanga did go over to The Crows Diner and talked with the Derry Path Finders and said he had a good time and that they are a nice group of people. Ellie Sarcione told the Commission of the 4 wheeler that was using the Albert W. Doolittle Conservation Trail. This is a posted NO TRAIL BIKES, NO HUNTING etc sign. She installed a new sign and will follow up with Ms. Ferrante, sitting as Chair, about a letter being sent to the person on Adams Pond Rd. Also discussed was the Cole Marsh area as the December Ice storm really did a lot of damage there, so there is a great deal to be done over there. We all welcomed Mr. Paul Doolittle as our new

alternate. The June 8<sup>th</sup> CPTA meeting may be changed to June 11<sup>th</sup> which will be discussed at our May 11<sup>th</sup> meeting
