The regular monthly meeting of the Derry Conservation Commission was held on 13 July, 2009 commencing at 7:30 pmPM, in the third floor meeting room of the Derry Municipal Center, with the M. The minutes of the last meeting were read and approved as read. Motion by P.Doolittle, second by R. Buzzanga, passed unanimously.

<u>CHAIRS REPORT</u> Bill from Derry feed for \$58.62 for straw and poles. Motion by A. Chappell, all approved. Motion carried 7-0 Bill from Bensons \$24.49 money spent for chain and lock at Broadview Farm, to secure gate. Motion by D. Wiley second by E. Sarcione motion carried 7-0

Benson's hardware wanted to know if they could fax us a bill or email a bill. We do not wish either of these and to bill the Chair of DCC no name of the Chair as it may be changed from time to time. Voted and passed by all 7 - 0

SITE REVIEW on the 27th of June we did a site walk that already had the approval of the Zoning board. Mr. &Mrs. Jean-Pierre Bonenfant tax map lot55 48.81 Chester Rd. There is a discussion about either a porch or deck. A motion was made to send a letter to the DES Shore land Program advising that we reviewed the plans at our June 22 meeting and conducted a site walk on June 27th and wish to be updated on their current plans. They are 34.56 ft. away from Beaver Lake, so they are under the 50ft requirement. We would want to see the final plans. At that point we will make a final comment. We are very interested in this as this is also involving the new Shore Line Protection act. A motion was made by R.Buzzanga and seconded by D.Wiley. All approved 7 - 0

BROADVIEW FARM Wood chips are there, we need newspaper and then D. Wiley will call us to help make the paths. This will be a big help. Also, Margie and Ellie will work on a plaque for Broadview Farm for the Buttolph family and the Alice V. Young family. A motion was made to allot up to \$100.00 dollars for the plaque. Motion by D. COLE MARSH M. Ives, Chair, along with Mike Fowler from the town of Derry water Dept. and Mr. Craig Durrette, also town of Derry have gotten a bid to do clean up at Cole Marsh. We will be using monies from FEMA, There were 2 motions made, one for taking \$1800.00 from the Forestry Account and one for taking money from the Administrative account. Both passed, with 5-2 R.Buzzanga no and D.Wiley no.
