# Minutes of Public Meeting August 23, 2010

On August 23 at 7:30 the Derry Conservation Commission met in the NH Room of the Derry Municipal Center. Go Green Committee – Paula Frank gave report. Boat ramp will be closed at Beaver Lake from September 13<sup>th</sup> through October 4<sup>th</sup>. First year's focus for committee has been on stream teams for Beaver Lake, recycling and walks this summer at conservation sites. The stream team service project was a success with students from Pinkerton Academy. They were able to get samples from Manter Brook with soap suds and oil detected during the testing. Due to the dry weather, none of the other tributaries were done. Stream teams expected to continue next summer again under the leadership of Mr. Cox.

Broadview Farm - Richard Tripp will call Paul Doolittle when wood for tent platforms is available.

Cole Marsh – A fire recently occurred there which got out of control. The fire department received a call and the fire was extinguished. A number of beer cans were noted. A motion was made by Jim Arruda, second by Beverly Ferrante, to purchase five locks (with standard key and chain) for the amount of \$100 from the administrative account to permit Fire Department for access to the site. Motion passed with all members voting aye.
