Minutes of Public Meeting April 11, 2011

Land Steward's Meeting:

At the land steward discussion, the DCC reviewed two kinds of monitoring reports, one for observations and one for marking boundaries and observing if easement or deed requirements are being met. Volunteers asked questions pertaining to how often to do reports and where they could obtain information. Their information requests go through the DCC, ie for GIS maps, easement restrictions, acreage, etc. Elizabeth Robidoux in planning has summarized all pertinent information on protected lands. This is still in draft but is a quick reference for answers on parcel map/sheet no., restrictions, acreage, etc. It is expected that a formal report will be done once a year. Observation reports can be done any time they are walking the property. We would like reports every six months. We received a request for another session on understanding the compass.
