Minutes of Public Meeting September 12, 2011

On September 12 at 7:30 the Derry Conservation Commission met in the third floor meeting room of the Derry Municipal Center. The following members were present: Jim Arruda, Paul Dionne, Paul Doolittle, Margaret Ives, Beverly Ferrante, Peg Kinsella, Richard Tripp, and Dennis Wiley. Peg Kinsella sat for Ric Buzzanga.

Motion by Paul Dionne, second by Beverly Ferrante, to accept the minutes for August 22. All aye except Peg Kinsella, Jim Arruda, and Paul Doolittle who abstained, motion carried. Minutes for two meetings are still not available and will be accepted at next meeting.

DES:

95 Conley's Grove – letter from DES detailing fines in the amount of \$15,000 for work not performed to standards.

35 Pond Road – letter received from DES identifying deficiencies from site review and requesting owner response.

18 Windham Road – letter received from DES indicating the site approval is given and no remediation is required.

Scobie Pond Road – letter received from DES that fill of 9,923 square feet is complete (DES approved permit #2010-00402). Chair to write letter to DES requesting clarification concerning whether the fill was cumulative with previous 1999 fill. It was also noted that the conservation commission had not received notice of the dredge and fill permit.

22 Germantown Road – letter of compliance from DES.

Derry Public Works (DPW) – Letter received from Mike Fowler on dredge and fill permit to remove lower dam at Beaver Lake in October. The dam at the Meadows remains intact and is the controlling dam for Beaver Lake water levels

Chair's Report:

Conservation Commission Clerk Position – motion by Paul Dionne, second by Beverly Ferrante, to pay Nutfield News \$126 from administrative account for DCC clerk position advertisement, motion carried. Selection of clerk is in process.

Summer Intern Stipend – motion by Dennis Wiley, second by Paul Dionne, for \$500 from administrative account to provide summer intern with stipend, motion carried.

Stationary supplies – Weber Forest mailing depleted stationary (letter head paper and envelopes). Motion by Paul Dionne, second by Beverly Ferrante to approve up to \$100 from administrative account to replenish stationary supplies, motion carried.

Quail Hill Nature Walk – walk will be conducted on October 8th beginning at noon. Starting point will be the Tiger Tail entrance. Dennis Wiley to provide maps.

Go Green – town wide cleanup the week of October 15th through the 22nd.

Pathfinders – Phil Bruno gave a short report which the chair presented about activities in Weber Forest.

Gagnon Easement – Paul Dionne reported that with this inspection the easement monitoring will be complete.

Broadview Farm Gardens – Peg Kinsella reported there were thirty gardeners for the forty four plots available. She noted the paths need to be widened in order to permit mower access.

Water Source Commission – a September 19th meeting is scheduled at the Planning Commission.

Land Stewards – a meeting/thank you party needs to be set up with them.
