OLD BUSINESS

Edward Garone – Frost Rd @ South Range 4-way Stop

Chief Garone received a neighborhood request to consider making a 4-Way Stop at Frost Rd @ South Range.

Alan Cote provided some pictures of the intersection for the Committee's review.

Jane Simard agrees that this intersection if difficult, especially when the leaves are on the trees.

Alan Cote did some pretty aggressive tree trimming this past summer and thought it had resolved the issue.

Chief Garone stated that was not a high compliance to the stop sign.

Alan Cote wanted to verify that there was truly a sight distance issue that warranted a 4way stop. MUTCD guidelines frown on installing 4-way Stops.

Alan Cote made a motion to table this item until after the foliage has returned to the trees (June meeting).

Seconded by: Al Dimmock MOTION: PASSED

Mike Fowler – PSNH Midnight Lighting

PSNH is going to be re-lamping the street lights in Spring of 2011 and would asked if we wanted to install timers that would shut off at midnight, possibly saving on our light bill.

Al Dimmock asked who would determine which lights would be shut off.

Alan Cote stated that the DPW would generate a list to be considered.

Al Dimmock felt that there were lights that should be eliminated. However he did realize that other people may feel differently.

Chief Klauber would like to see a spreadsheet of recommended lights to be considered or eliminated.

Alan Cote stated that the cost was minimal to install the timers if during the re-lamping process.

Chief Garone was not in favor of turning any lights off. He felt the Town should not consider turning any lights off at intersections or high density areas.

Alan Cote agreed that urban areas and intersections may not be considered a good candidate for the timer. However lights in a rural setting he felt would be ideal.

Randy Chase was not against turning lights off at midnight but would not want to see them off at intersections.

Al Dimmock asked when PSNH was going to begin re-lamping the Town.

Alan Cote felt PSNH would begin in the spring and would generate a map/list of lights to be considered for the next meeting.

Chief Garone asked if the risk benefit could also be included.

Lisa Peabody – Requesting a light @ Derry Traffic Circle

Alan Cote stated that there was currently a light in the middle of the rotary. He would have to drive by at night to see how dark it was in front of 4 Chester Rd before making a decision.

Chief Klauber drives Chester Rd about 3 or 4 times a day and agrees with Ms. Peabody that it is dark there at night. He felt business was picking up there as he also noticed that people are parking across the street. Motorists do not slow down when coming down Chester Rd into the rotary.

Chief Klauber made a motion to table this item until the next meeting. Seconded by: Alan Cote MOTION: PASSED
