## **BUDGET REVIEW**

#### IT/GIS

Doug Rathburn gave overview of his budget. Councilors asked questions regarding the Capital Reserve fund established for this department.

Motion by: Councilor Coyle to move \$50,000 in item #390 Other Professional Service into Administration seconded by Councilor Fairbanks. Vote: Failed 3-4-0 (Fairbanks, Coyle, Chirichiello, Benson)

Town Council had discussion on the amount and other economic development areas before vote taken.

Motion by: Councilor Benson to add \$80,000 to item #390 Other Professional Service in the Administration budget seconded by Councilor Wetherbee. Amended to \$75,000 Benson/Wetherbee Vote: 5-2-0 (Coyle, Fairbanks)

Frank Childs stated, the Transfer Station purchase of Trash Hauling Trailer had to be entered back into the budget as it had been removed prior to this evening's vote.

Frank Childs also updated Council on HB 351; Senate today sent the Tax Interest bill to committee.

## Information Technology

Councilor Coyle moved to reduce by \$10,000 (Kiosk), account # 740; seconded by Councilor Carney Vote: 4-3-0 (Wetherbee, Benson, Metts)

Frank Childs explained that this is not coming out of the Capital Reserve fund.

Councilor Carney moved the new bottom line of IT by \$484,801, seconded by Councilor Wetherbee. Vote: 7-0-0

Motion by: Councilor Carney to increase the Human Service line #810 by \$2500 for payment to the Derry Cooperative School District as the fiscal agent for Adult Learner Service subject to receipt of Adult Learner Service program specific balance sheet and income statement from the audited records of the fiscal agent of Adult Learner Service demonstrating fiscal conditions in need seconded by Councilor Fairbanks.

Vote: 7-0-0

There was discussion regarding this program prior to the vote.

#### **Town Clerk:**

Councilor Benson motioned to increase the Town Clerk's salary by 2.5%; seconded by Councilor Coyle. Vote: 6-1-0 (Fairbanks)
