Town Administrator Stenhouse stated that several years ago the Derry Town Council set up a revolving loan fund aimed at encouraging business expansion and job creation within the Town of Derry. This program was administered by the DEDC. Since the town has severed its financial relationship with the DEDC, the Town Administrator has been working with the Rockingham Economic Development Corporation to reinstitute the loan program. Action requested of the Council is two-fold. First the Council is being asked to authorize the Town Administrator to contract with REDC to allow REDC to administer the loan program. In addition Council is asked to make a supplemental appropriation in the amount of \$136,772.52 to augment the \$113,227.48 that the Town already maintains in its existing loan fund. Bob McDonald of the REDC is present to answer any questions concerning their administration of loan programs. REDC has 15 years of successful experience in these programs and have not had a loan go to default during this period.

Stuart Arnett – gave the Town Council his thoughts on the REDC and their reputation for loan originating experience which has been excellent.

Councilor Coyle - stated the loss from the DEDC was \$36,000. He stated he doesn't think the town should be in the lending business.

Councilor Benson – inquired in regards to the loans outstanding was there any chance the town might recover some of these funds. Mr. Stenhouse stated that was highly unlikely

Chairman Metts called for vote or motion to table as Councilor Carney was absent.

Councilor Benson – asked what other communities have loan funds. That information will be obtained for the next meeting.

Bob MacDonald defined some the project areas where loans are being made as mostly in Rockingham County. In addition many of the cities in NH such have Economic Development Revolving Loan Programs..

09-151 School Funding Resolution

Chairman Metts has spoken with Councilor Carney on this Resolution and he stated it was okay to go ahead and move to approve the School Fund Resolution.

Councilor Fairbanks asked questions regarding this funding resolution. She questioned if a similar document had come from school board. She wondered if it would behoove the Town Council to make its presence at the State House by asking the Governor to meet with the Derry Town Council.

Move that the Derry Town Council accept the School Funding Resolution as follows;

SCHOOL FUNDING RESOLUTION #09-151

WHEREAS: The Town of Derry's children are set to lose \$7.5 million in funding to

the Derry School District from the State of New Hampshire for the Fiscal

Year beginning July 1, 2011; and,

WHEREAS: The Derry Town Council recognizes the importance of maintaining and

enhancing quality educational opportunities for all of Derry's

children; and,

WHEREAS: The Derry Town Council recognizes that it is a right, not a privilege,

in New Hampshire to receive a quality education and that minimum funding for that education be provided by the State of New

Hampshire under the guidance and direction of the State's

Constitution; and,

WHEREAS: The Derry Town Council, on the behalf of the families of Derry, New

Hampshire, request that current funding allocation equations be revised by

the New Hampshire General Court and Governor John H. Lynch; and,

WHEREAS: Furthermore, it is unacceptable for the State of New Hampshire to place

this undue burden on the Town of Derry, in the form of a reduction of funding to the school district in a manner that will be destructive to our educational system, to our children's educational opportunities, to our tax base, to all those who call Derry home including our business community

and to the very future of our community.

NOW, THEREFORE, we call on our State Legislature and Governor John H. Lynch to immediately address and correct this critical error.

Councilor Benson – It had been discussed before that if there were a surplus there would be a discussion on the amount and the use in the accounts of the Town before year end. He now understands that the year end close has taken place. He inquired as to the status of the "snow removal" reserve. The T.A. stated he would get that information to council. Councilor Benson stated that he would like in future years for Council to have a year end discussion before the formal close of the books.

There has been no resolution to the "big sign" issue around town. He would like a letter drafted to be sent to the Planning Board to handle this. He would also like to discuss the parking lots next to the Adams Memorial Building.
