Schedule Public Hearing - April 20, 2010 - Amend the Code of the Town of Derry, Section 165-30 Zoning Map by rezoning certain parcels from Medium High Density Residential District Zone to Medium High Density Residential District II -Purpose of Amendment: to rezone 68 properties that lie within the corner of Birch Street and East Broadway to include Oak Street, Park Avenue, Fenway Street, Grove Street & Wilson Avenue from Medium High Density Residential to Medium High Density Residential II. If amendment is adopted, these properties will be subject to the Medium High Density District II zoning requirements contained in Section 165-45.1 of the Derry Zoning Ordinance. An amendment to the zoning map delineating the lots in the Medium High Density Residential II District is being adopted to reflect these changes. # Administrator's Report - Larry Budreau Acting Town Administrator

\*\*\*\*\* Emerson Heights

FY2010 budget anticipated the sale of tax deeded properties @ \$700,000; \$350,000 was to be used to offset the present budget and the remainder \$350,000 to go to Land and Building Capital Reserve Fund. To date the amount collected was \$91,500 through auction. To increase the marketability of the Emerson Heights properties the Town needed to improve the septic plans. The plans should be ready by May 2010. This means that the properties will unlikely be sold before the end of this fiscal year.

\*\*\*\*\* Meeting with School Department

Chairman Benson, Town Administrator Stenhouse, Kevin Gordon & Brenda Willis of the School Board, and Mary Ellen Hannon, Superintendent of Schools, met recently to discuss possible legal action that the schools may take against the State of New Hampshire regarding school funding. All agreed that it would be in the best interest of the Town Government to support the schools if a

decision to take legal action is made by the School Board. The Town and Schools will work together to do what is right for Derry's school children and the Derry taxpayers.

#### Public Hearing

**10-17** Revision of Town of Derry General Code, Section 118, Second Hand Dealers

Chief Garone reviewed the changes to the Code. The Code did not include many items that are now the target of theft and trade. It also did not include "Pawn Dealers" as Second Hand Dealers.

Paul Dionne, Worthley Rd – He is a property adjuster and supports the changes.

Jim Ganeso, Derry Coin – These show a change in times. He approves changes.

Greg Germaine, Gem Jewelers – He questioned use of photocopies of items. Asked why in Section 118-2 trade-in jewelry was taken out of exemption and articles of \$50 or more was removed all must now be reported.

Chief Garone – stated photocopies would be used as an investigative tool. Trade-in jewelry could be exempt. The articles of any value that must now be recorded he requested not be removed.

Debbie Mackey, Once a Pawn in Time – She is in agreement with this Code. It's the not the items as much as the people going from place to place the paperwork will show this. She questioned licenses for local business what about insurance companies "we buy gold" or GameStop.

Tom Carrier & John Bovair PWW – Tom gave an overview of this venture for the new Town Councilors.

PWW is applying for SRF money. The sooner they have a vote it will make it easier. Tom stated they would complete project by summer.

The Derry Town Council moves to rename the "Scobie Pond Water High Service Area Improvements Fund" to Water System Capital Improvement Fund" and establish a \$400,000 budget for the purpose of East Derry Water System expansion, extending the Derry Municipal Water System in accordance with the Derry – Pennichuck Water Works Municipal Water System Interconnection Agreement – The source of the funding of the project shall be from a transfer of \$200,000 from FY 2010 Water Division Other Improvements (99032003 730000) and \$200,000 from the Scobie Pond Water High Service

Area Project (90023200 730000). Any remaining funds at the completion of the Scobie Pond Water High Service Area Project shall be returned to the Water Division Fund Balance. Wetherbee/Coyle Vote: 7-0-0

10-43 Renew Public Health Network Grant

Garret Simonsen – Funding the Public Health Network provides the financial support for the Public Health Network Coordinator's regional activities.

#### **New Business**

**10-55** Solid Waste Disposal Contract Extension 2011-2016

Mike Fowler & Joan Cornetta – Mr. Fowler gave an overview of the contract. Scott Hagermier MERC Rep is in audience for questioning. The staff recommends that the Town Council waive Charter Section 9.10 in lieu of soliciting proposals/quotes for trash disposal at the end of 2011 given the favorable terms of the existing contract.

Motion: The Derry Town Council hereby waives the provisions of the Town Charter Section 9.10 for the purpose of extending the trash disposal contract with Maine Energy Recovery Corporation for five years to expire in 2016. Wetherbee/ Vote: 6-0-1 (Coyle)

**10-56** Authorization to Fill Cable 17 Administrator Position

Larry Budreau stated the Town Council has required the Town Administrator to seek approval before hiring. The Station cannot be sustained by one person.

Councilor Coyle questioned why hire now; they will look at situation during the budget. Council requested to see a job description.
