Chuck Hemeon reviewed the code of EMS transport services. The current fee schedule was approved for the Emergency transportation system. They are called upon to transport non-emergency patients. Mr. Hemeon recommended that council approve HCPCS code A0428 (Derry BLS Non-Emergency to collect a fee for these types of transports.

Chairman Benson allowed the Town Clerk to discuss some voting requirements. Councilors agreed.

Ms. Neale informed the Town Council that there is required training prior to State and Federal Elections given by the Secretary of State and Attorney General's office for Election Officials.

The State also has an online training program called NH Votes for Selectman, Town Clerks, Ballot Clerks, Moderators and Supervisors of the Checklist. The Secretary of State's Office is requesting that the Council take the test. There are 23 lessons divided into 11 units and it will take at least 2hrs or more to complete. It contains a lot of reading on Election Law. The Town Clerk provided the Town Council with the sections specifically designed for the Selectman as reference, AVS forms for password accessibility. Ms. Neale requested that the Town Council review the training specifically for what is required of a Town Councilor during all Elections.
