Council Requests / Open Discussion

Councilor Fairbanks is still being besieged by dog complaints about barking dogs and dogs defecating.

Chief Garone stated an ordinance could be created where a lease could be required. Ms. Fairbanks would like to educate the public on these laws. She would like Animal Control to address the Town Council on this issue.

Chairman Benson suggested an Educational Community piece be done on CTV17. Chief Garone explained that if the PD is called when the incident is happening and the PD responds and views the incident they can act.

Mr. Anderson introduced Jeremy Bourgeois, our NHMMA Intern for the summer and then asked the Town Clerk to explain the Civil Forfeitures.

Ms. Neale, Town Clerk reviewed for the public the laws which apply and procedures of licensing a dog, late fees, and the Civil Forfeitures (fine) which were recently mailed out due to non-licensing. New dog owners receive postcards. The notification on the civil fine states to notify the Town Clerk if the dog has moved or is deceased.
