WHEREAS, The Town Council of the Town of Derry, New Hampshire (the "Town Council"), who also act as the Water Commissioners for the Town, has appropriated the sum of One Million, Nine Hundred, Sixty-Eight Thousand, Five Hundred Dollars (\$1,968,500) in the Derry FY2012 Water Enterprise Fund Budget for the purpose of completing the FY2012 Municipal Water System Improvements/Expansion: Route 28 project as identified in the Derry Water System Master Plan and Town of Derry Master Plan as future areas to be serviced by municipal water;

NOW THERFORE BE IT RESOLVED: That the Town Council authorizes that \$1,968,500 of the aforesaid appropriation be raised through the issuance of bonds or notes (the "Bonds") under and in compliance with the Municipal Finance Act, RSA 33, as amended;

RESOLVED: That the Town Council hereby appropriates up to \$35,000 of interest or other earnings on the invested Bond proceeds for the purpose of the aforesaid Project;

The Derry Town Council, acting as water commissioners, moves to approve the following cost recovery method for the approved FY2012 Route 28 Water System Improvements Project:

All properties in the Water System Master Plan Zone 1 improvements area (Route 28 By-Pass north and Route 28 west of Island Pond Rd.) shall pay existing Derry water connection fees in accordance with the Code of the Town of Derry: Water Use Ordinance.

All properties in the Water System Master Plan Zone 3 improvements area (Route 28 south of Island Pond Road) shall be assessed at the time of the notice of availability their calculated share of the gross costs for Zone 3 improvements. Said assessments shall be calculated based on the parcel area for commercially zoned properties or in the case of residentially zoned properties, the number of living units.

For existing buildings, assessments shall become payable at the time of connection of the building to the public water system. For properties which may be redeveloped, assessments may be applied as an offsite improvement by the

Planning Board as a condition of approval and therefore become payable at the time of redevelopment whether or not connection to the public water system is made.

#### WORKSHOP

Frank Childs, David Gomez, Barbara Chapman, David Cornell, Assistant Director of the Property Appraisal Division of DRA, Present

Please see Assessing Plan Report attached herewith as reference. This is the document was presented at the workshop.

Mr. Childs made some brief comments having looked at the operation of the department and the bottom line from a cost standpoint.

There are costs that can be reduced. Derry and the City of Keene have a strong program are the only ones in the state.

David Gomez gave explanation and history of town's assessing office since he has been here from 1981 to present. The goal since the mid 1980's has been to keep assessments up to date based on the realization that property taxes in the State are the single most import source of revenue. The BTLA was clear they wanted a definitive plan to be presented that would reduce the number of abatement filings. The BTLA ordered a reassessment of all properties to take place effective 4/1/93. The order was lifted on 7/1994. Mr. Gomez enlisted the assistance and advice

of the City of Keene on efforts to assess all properties each and every year. The Keene plan had been in existence since the late 1970's. In order for the Derry office to maintain yearly or biennial assessments three things needed to happen

- 1. The database computerized
- 2. Staffing needed to increase
- 3. More space was needed for the department

In 1999 Derry launched cycled inspections.

In 2003 state wide standards finally came into play. The DRA began annual reviews of local assessing practices.

In 2006 working with then Town Administrator Marcoux and CFO Childs an RFP was developed and VISION Appraisal was chosen to do inspections for complete interior and exterior measurements and list properties.

Note: on pages 8 – 12 of Assessing Division Report of Operations & Budget dated11/15/2011 "Cost Consideration" There are reported changes to the operation and savings of the department.

David Gomez stated the goal is now to go out every two years as the market remains in poor condition. As the real estate market changes Assessing will keep the Council informed and the plan may change so that they can go out as often as is necessary.
