***** Intro to FY 2013 Budget

Budget has been reduced by \$90,000 from submission of Department Heads. Approval of purchasing an ambulance instead of leasing. The budget is \$313.00 below tax cap. The CPI is 2.3%. This is an increase from \$9.52 to \$9.82 on the tax rate. Town expenditures increased as well as a proposed revenue increase. Budget projects the elimination of 2 full-time positions and changing 1 part-time position to a full-time in Cable TV. Included in the budget is the Rockingham Road bond for extension of water and sewer.

12-34 Town Council Rules

Mr. Anderson and Mr. Budreau took suggestions from the last meeting, revised and added some information to the Town Council Rules.

Town Council reviewed page 6 Section 13, whether to remove the last three bullets. All agreed to leave in.

Page 6, Section 13, Co-sign with the Administrator all purchase orders in excess of \$10,000.00 and all leases and contracts regardless of the total amount, some Councilors agreed to leave in.

Motion to change section 13 bullet 9 to change from excess of \$10,000 to \$20,000, Moved by Councilor Wetherbee, seconded Councilor Milz Vote: 5-1-1 (Chirichiello, abstained Benson)

Motion to add section 16 - Non-Public Meetings, The Council shall follow NH RSA 91-A in the conduct of all non-public meeting, and renumber section 17. Move by Councilor Wetherbee, seconded by Councilor Katsakiores.

Vote: 7-0-0

Mr. Anderson explained section 17, explains "Changing the Rules". Chairman Benson stated that they would do their 1st reading at the next meeting and vote.

12-35 Town Charter Adoptions

Mr. Anderson and Mr. Childs reviewed the Charter amendments voted on by the citizens and passed at the March 13, 2012 election.

- 1. Allow Independent Auditors for RFP but not necessarily change auditors
- 2. Allowed the TA with simple TC approval on appropriation to reduce appropriations
- 3. Formerly add Deputy Town Treasurer to Charter
- 4. Waive bid process under certain circumstances

Mr. Anderson stated he would bring forward a timeline for the next set of charter changes for the September ballot.
