Councilor Fairbanks sought to schedule a joint meeting in January as required by the Town Charter and inform the Planning Board ahead of time to send any goals or objectives to him for this workshop. Based on Council input, the meeting was pulled forward and scheduled for the first meeting in December.

\*\*\*\*\* New Hampshire Municipal Association Workshop – Elected Officials

NHMA will provide a workshop on Conflict of Interest. This will be a 2–3 hour workshop. Larry Budreau will coordinate schedule.

Chairman Fairbanks attended the NH DOT 10 Year Highway Plan meeting. The Drew Rd Bridge is scheduled for 2019.

#### Town Administrator's Report -

The Dog Park was closed the week of September 23 for re-grading and reopened Monday, September 30.

Rockingham Road project is ongoing and on schedule.

- Transfer Station extended summer hours will end on Wednesday, October 2.
- The last Farmers Market sponsored by the town was held on Wednesday, September 25. However, they will continue for the next four weeks and the market will be held at the Derry Feed parking lot on Manning St. Food vendors will need to be licensed as this event is no longer sponsored by the Town.
- The annual Town Auction is scheduled for Saturday, October 26. Items up for auction will be listed on the website
- Town owned DiFeo property will be getting cleaned up this fall. Progress was stalled until all 11 monitoring wells on the property were located.
- DPL has converted from oil to natural gas. The Library anticipates a 50% savings of heating fuel cost.

Mark Flattes, Linlew Dr. – He asked if the NHMA workshop should be held off until after the next election for new councilors.

Councilor Wetherbee stated that invitations should be extended to other boards and commissions for the New Hampshire Municipal Association Workshop - Elected Officials Mr. Budreau stated that he would also like the opportunity to address the boards and committee members on the subject of record retention at this workshop.

#### Public Hearings -

13-99 Municipal Water Rate Increase

Tom Carrier, Public Works Deputy Director, gave an overview of this request. This rate increase is due to an increase placed upon the town from Manchester Water Works. This will increase the annual average Derry water bill 1% from \$342.12 to \$346.25. With this increase Derry, will remain 30% lower than other communities. Without this increase, it will cause a shortfall of \$10,000 to the town's water budget.

### Open Public Hearing Councilors Wetherbee/Benson 7-0-0 No public input

#### Close Public hearing Councilors Katsakiores/Osborne 7-0-0

#### Council Discussion:

Questions evolved around when the rate increase was received from MWW and when was the last increase? Mr. Carrier replied that the last one was back in March 2013 from MWW but prior to that there has not been one since 2007-2008.

Councilor Benson does not support this increase due to fact the increase is coming after the budget process. Mr. Carrier stated that the Town's budget workshops are in March/April and MWW board meets in June, which is after our budget session. Councilor Wetherbee agreed with Councilor Benson.

The Derry Town council, acting as the Water Commissioners, moves to amend the Derry Water Use Ordinance rates by increasing the Municipal Retail Water Rate from \$2.50 to \$2.53 per 100 cubic feet and the minimum quarterly base charge from \$23.03 to \$23.20 per living unit or commercial metered connection effective on all water used on or after December 1, 2013.

Motion by Councilor Osborne, seconded by Councilor Cardon Vote: 0-7-0 (motion failed)

**13-100** Accept grant for three portable radios from NH Department of Safety

Chief Garone explained the use of this equipment and its value to the department.

Kelly Martin, Bayberry Lane – asked if the department has this capability now. Chief Garone replied yes.

#### **13-107** Approve PRIMEX Three Year Contract Extension

Frank Childs, CFO, presented the Primex Cap program. The current property & liability, Workers' Compensation and Unemployment Compensation coverage will expire in June 2014. Frank recommended that the Town commit to an additional three years of coverage with Primex.

Move that the Derry Town Council approve the Primex Property & Liability and Workers Compensation Contribution Assurance program Agreements for the period July 1, 2014 through June 20, 2017 and authorize the Council Chair to execute the Agreements and the aforementioned Resolutions.

#### **13-108** Energy/Environmental Advisory Committee Presentation

Maureen Reno – gave an overview of the Energy efficiency policy created by a prior Town Council. This Board was established in 2009 and their mission is to promote energy conservation and efficiency, while also exploring ways to reduce carbon emissions among the town's residents. They have successfully worked with town administrators and staff on projects such as energy saving measures for the Taylor Library and Veterans Hall. This board provides lectures educating the public on how to reduce energy costs. The next one is at the Derry Public Library on 10/26/13 10am – noon.

This advisory board seeks to be involved in vehicle purchases and projects. They would like to be informed of new purchases or projects to give advice on RFP's. They are willing to host a workshop for the Town Council.

Councilor Cardon stated his frustration as board member in the past was based on the resolution that was made by that past Town Council and the advisory board has never been requested to give advice.

#### **Council Requests / Open Discussion**

Councilor Katsakiores wanted to recognize the Derry Village Rotary for building the pavilion at the Don Ball Park and to congratulate the Benson family for their 100 year Anniversary.

Chairman Fairbanks asked where the E911 mapping process is at. Mr. Budreau explained that Chief Klauber is away and will follow-up with him when he returns.

Councilor Katsakiores stated that she received an email from Mr. Burtis regarding the C.E.R.T program and was wondering if Chief Klauber could give a report on this program.

Councilor Dimmock – questioned DiFeo property issue? Mr. Budreau repeated his report from earlier.

Councilor Benson asked if there was an RFP or a marketing plan for the DiFeo property and has any timeframe been set so that the Council knows where they are at? Councilor Cardon stated that he would like to see the property developed into a park.

The Town of Derry further acknowledges that by extending its Membership Agreement for three (3) coverage period years, the Public Entity Coverage Documents, General Conditions Section (L) ("Terminating Participation in Our Program(s)") is suspended during year one (1) and year two (2) of the three (3) year term, as there is no right to cancel or terminate during year one (1) and year (2) but shall be reinstated for the end of year three (3).
