# 12-107 Charles & Cheryl Stanion

Variance to the terms of Article VI, Section 165-45.B.1.d.ii of the Derry Zoning Ordinance to allow the construction of a screen porch, attached to an existing shed, less than 15 feet from the side lot lines. 5 Everett Street, Parcel ID 29054, Zoned MHDR

Charles Stanion, owner, read his application for the Board. Mr. Stanion said that the existing shed already has a concrete pad attached to it that he wished to utilize for a screen porch and create a storage area over the shed area so he had a place for additional storage.

# **Board Questions**

Mr. Osborn asked if the proposed structure would look like the existing home. Mr. Stanion said yes.

Mr. Virr asked if was being placed where the fence was located on the side so it was out of view. Mr. Stanion said yes.

Mr. Perkins asked if there was an alternative shed on the property. Mr. Stanion said yes that it was existing on the other property.

Mr. Dimmock said that the shed in question belonged to #46.

Mr. Virr asked if there were any structures close to the lot lines. Mr. Stanion explained the area for the Board.

#### Favor

Connie Dimmock, High Street, said that she was in favor of the applicants request as it would not be seen from the street and that it would improve the yard.

# **Code Enforcement**

Mr. Mackey said that the applicant is requesting a variance for the construction of a  $12' \times 15'$  screened in porch attached to the existing shed. The porch, as proposed will not meet the side lot line setback requirements. In 1992, a variance was granted by the ZBA to allow the existing shed to be no closer than 8' to the left side lot line (see attached). Our records indicate that a building permit was issued for the construction of the shed in September of 1986. If approved, the applicant will be required to obtain a building permit from our office. There are pictures in the file for review by the Board.

# **Board Questions**

Mr. Virr asked how long had the home been owned. Mr. Stanion said that they have resided there for 30 years.

Mr. Osborn motioned to go into deliberative session.

#### **Deliberative Session**

Mr. Dimmock said that in the past there have been similar situations that have been allowed 2-3 feet from the lot lines and that he felt that this request was no different and that there would be no visibility from the street.

1. Subject to all Town and State permits and inspections.

2. 1 year to build or variance shall be void.
