### **Meeting Minutes**

Bill made a motion to accept the meeting minutes, as submitted, from the December  $8^{th}$  meeting. Judy  $2^{nd}$  the motion. – Motion passed.

#### **Bills**

\$20 invoice from Quill (total was \$78.05). Bill made a motion to pay the Commission's share of the Quill bill. Judy  $2^{nd}$  the motion. – Motion passed.

### Flat Rock Hill

Judy mentioned that someone drove a pickup truck through the woods from Stone Arch Bridge (High Street) to Flat Rock Hill (Mill Street). The Commission will post additional "no motorized vehicle" signs in both areas.

Judy also asked that the Commission recognize the O'Loughlin's for all the work they have done at Flat Rock Hill. The Commission will send out a certificate thanking them.

#### **Pelletier Property**

While walking through the old Pelletier property on River Street, Judy noticed a broken down bus full of clothes on hangers. She also said that there is a pile of logs next to the Unkety Brook side of the property. The logs are not near the wetlands; however, Judy felt that the Selectmen need to be aware of them.

#### **Christmas Tree Sale**

The final count for the Christmas tree sale was \$1,184. Per Attorney Larkin, the Secretary will put an article in at Annual Town Meeting transferring the funds to the control of the Conservation Commission.
