Conservation Commission Minutes August 26, 2009

Meeting was called to order at 7:34pm by Chair, Leah Basbanes

Meeting held: At the Dunstable Town Hall, lower level

Meeting Minutes

Marilyn made a motion to accept the meeting minutes, with noted correction, from the August 10th meeting. Alan 2nd the motion. – Motion passed.

Bills

Jeff made a motion to sign off on the bill for certified mail. Alan 2nd the motion. -Motion passed.

Hardy Street Property (Carter) Grant

The Town overwhelmingly supported the purchase of the Hardy Street property at the Special Town Meeting on Monday night (August 24th). A letter informing Celia Riechel about the affirmative vote was mailed on August 25th. The Conservation Commission should hear from the state regarding the application for the LAND grant in September.

Pond Street Property

Anne Gagnon, from the Northeast District of Division of Fisheries & Wildlife called regarding property that is for sale on Pond Street. Alan called the broker who explained that the owners are selling one lot out of the twenty-five (25) acre parcel. Currently, the property is in Chapter.

Farnsworth Property

Alan explained to the Commission that the pine market has rebound, and he suggests that the Conservation Commission proceed with removing about 73,000 board feet of pine on about 19 acres of Farnsworth Property. The Commission would expect to get approximately \$6,000-\$7,000 (or more) for the pine. Gary Gouldrup will be in charge of the operation and the wood will be brought out through the Fish and Game property (Gary has already received permission). Alan made a motion to authorize Leah to sign the "Appointment of Agent" form for the project. Marilyn 2nd the motion. – Motion passed. Marilyn then made the motion to authorize Alan Chaney to send out all the abutters' notices. Jeff 2nd the motion. – Motion passed.

130 Hardy Street – Blackburn Property

The Commission sent the Enforcement Order to Mr. Blackburn by certified mail. Unfortunately, we have not received the copy back from the post office confirming receipt. Leah will stop by to
