# **Conservation Commission Minutes September 12, 2011**

## **Meeting Minutes of August 22, 2011**

Marilyn made a motion to approve the minutes, from the August 22nd meeting. Juan 2nd the motion. – Motion passed unanimously.

#### Review/Sign Bills and Payroll

The secretary's payroll was signed.

#### Flat Rock Hill Culvert

#### **Blanchard Hill**

Judy told members that she had been up on Blanchard Hill and was disappointed to see that one of the picnic tables had been destroyed, there were beer cans scattered about and a fire was still smoldering. Judy talked to the Police who said that a pick up truck had been seen in the area.

#### **Demolition of Garage at Unkety Woods Preserve – Woods Court**

Alan received a quote of \$4,500 for the demolition and removal of the garage on Woods Court. Included in the price is the cost of burying the slab and concrete block at the site. The Commission would be responsible for pulling the permit(s) and getting the electricity disconnected. A 2<sup>nd</sup> quote is expected and it was mentioned that we may need to go to Town Meeting for funding. Alan also said that he was waiting to hear from the Fire Chief about using the garage for safety training.

#### <u>Letter for Chief Rich – 804 Main Street – Controlled Burn</u>

Chief Rich requested a letter from the Commission regarding a controlled burn of the building at 804 Main Street. There is an Order of Conditions on the property and the Commission had previously signed the demolition and building permits. The Commission discussed that they did not have any issue with the controlled burn as long as the runoff from the fire water does not make it into the stream bed. A letter will be given to the Fire Chief.
